AN ORDINANCE AMENDING CHAPTER II SECTION 7; CHAPTER IV SECTION 12, 18 & 21 (C); CHAPTER XVIII PENAL PROVISIONS FOR SECTIONS 8, 9, 10 AND 18 (A) OF ORDINANCE NO. 15, SERIES OF 2008, OTHERWISE KNOWN AS THE SANITATION CODE OF PASIG CITY.

BE IT ORDAINED, as it is hereby ordained by the Sanggunian Panlungsod of Pasig City in session duly assembled that:

Section 1.

1.1 Chapter II under Section 7 will be read as follows:

All results of laboratory tests and radiologic examinations under Section 5 hereof shall be confirmed and validated by the City's Public Health Physicians on duty at the City Health Office.

Applicants who will avail of the services of the Pasig City One Stop Clinic (PCOSC) will be exempted to pay the P50.00 validation fee since the results enacted from the PCOSC. Under Section 58 of the Sanitation Code of Pasig City, a fee of Fifty Pesos (P50.00) is charged as employment fitness consultation fee/validation fee.

1.2 Chapter IV, Section 12 will be read as follows:

All persons employed by a food establishments, public or private market, whether food or non-food handlers, are required to secure Health Certificates from the CHO. It **shall be valid until the end of the current year** subject to the results of health examination conducted on the concerned employees.

1.3 Chapter IV, Section 18 will be read as follows:

18. Vendors all traders of fruits, vegetables, fish and meat are prohibited to use colored and/or reflectorized colored shades in marketing their products.

18.A It shall be prohibited to process foods inside all public and private markets, flea markets and the like.

- a.) Longganisa/tocino making or any meat products.
- b.) Any other food products.

1.4 Chapter IV, Section 21 (c) will be read as follows:

21(c) Monthly Microbiological Test and Semi-Annual Physico-Chemical Examination of water source.

Section 2. Penalties will be amended as follows:

2.1 For violation of Section 8, Chapter III, the penalties will be as follows:

- First Offense : Fine of One Hundred Pesos (Php100.00) and temporary ban to ply route until clearance is secured.
- Second Offense : Fine of Five Hundred Pesos (Php500.00) and temporary ban to ply route.
- Third Offense : Fine of One Thousand Pesos (Php1,000.00) and permanent to ply route.

2.2 For violation of Section 9, Chapter III, the penalties will be as follows:

- First Offense : Fine of five Hundred Pesos (Php500.00) any temporary closure of establishments until examination results are obtained.
- Second Offense : Fine of Two Thousand Pesos (Php2,000.00) with cease and Desist of operation of store for two (2) weeks.
- Third Offense : Fine of Five Thousand Pesos (Php5,000.00) and permanent closure of water station.

AN ORDINANCE AMENDING CHAPTER II SECTION 7; CHAPTER IV SECTION 12, 18 & 21 (C); CHAPTER XVIII PENAL PROVISIONS FOR SECTIONS 8, 9, 10 AND 18 (A) OF ORDINANCE NO. 15, SERIES OF 2008, OTHERWISE KNOWN AS THE SANITATION CODE OF PASIG CITY.

For violation of Section 10, Chapter III, the penalties will be as follows:

First Offense : Fine of Five Hundred Pesos (Php500.00) and/or imprisonment of one (1) day or community work of ten (10) hours.

Second Offense : Fine of One Thousand Pesos (Php1,000.00) and/or imprisonment of Five (5) days or community work of Twenty (20) hours.

Third Offense : Fine of Two Thousand Pesos (Php2,000.00) and/or imprisonment of Ten (10) days or community work of Thirty (30) hours.

2.4 For violation of Section 18.A as mentioned in this Ordinance, Chapter IV, the penalties will be as follows:

First Offense : Fine of One Thousand Pesos (Php1,000.00) and Confiscation of products.

Second Offense : Fine of Two Thousand Pesos (Php2,000.00) with cease and desist of operation of stall for Two (2) weeks.

Third Offense : Fine of Five Thousand Pesos (Php5,000.00) and Permanent closure of stall.

Confiscated food products shall likewise be donated to the inmates of Pasig City Jail.

Section 3. Separability Clause – if for any reason, any section or provision of this amending ordinance is declared illegal or unconstitutional, other section or provisions hereof which are not affected is hereby repealed or modified accordingly.
