AN ORDINANCE CREATING ADDITIONAL TEN (10) TEACHER II; FIVE (5) TEACHER III; THREE (3) ADMINISTRATIVE OFFICER I AND TWO (2) ADMINISTRATIVE AIDE (CLERK I) AT THE SPECIAL CHILDREN EDUCATIONAL INSTITUTION, PRESCRIBING PERSONNEL COMPLEMENT, SALARY GRADE, COMPENSATION, QUALIFICATIONS AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, the City Council approved last February 19, 2003, city Ordinance No 3, Series of 2003, establishing the Special Children Educational Institution;

WHEREAS, in preparation of the 2013-2014 school year, there is a need for additional teaching personnel for the ninth year of operation.

NOW, THEREFORE, THE SANNGUNIANG PANLUNGSOD, IN SESSION ASSEMBLED THAT:

Section 1. CREATION – There is hereby created additional Ten (10) Teacher II; Five (5) Teacher III; Three (3) Administrative Officer and Two (2) Administrative Aide III (Clerk 1) at the Special Children Education Institution.

Section 2. PERSONNEL COMPLEMENT, SALARY GRADE, MONTHLY COMPENSATION and QUALIFICATIONS – The compensation, salary grade and qualifications of the additional Ten (10) Teacher II; Five (5) Teacher III; Three (3) Administrative Officer and Two (2) Administrative Aide III (Clerk 1) at the Special Children Education Institution are as follows:

Section 3. APPOINTMENT – All personnel shall be appointed by the City Mayor upon the recommendation of the Pasig City Selection Board.

Section 4. APPROPRIATION – There is hereby appropriated the sum of Six Million Five Hundred Forty Five Thousand Three Hundred Ninety Pesos and 80/100 (P6,545,390.80) to cover payment for the salaries, allowances and other mandatory expenses of additional 10-Teacher II; 5-Teacher III; 3-Administrative Officer I and 2-Administrative Aide (Clerk I) for the next twelve months, compiled as follows:
