AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 6-90 AS AMENDED ENTITLED "AN ORDINANCE AUTHORIZING ORGANIZATION OF BARANGAY SECURITY AND TRAFFIC FORCES, GRANTING THEM CERTAIN PRIVILEGES, APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES.

SECTION 1. The title of the Ordinance is hereby amended to conform to its contents of including the Barangay Council members, Secretary, Treasurer and Sangguniang Kabataan Chairman among the recipients of the privileges, hence to be read as follows: AN ORDINANCE AUTHORIZING ORGANIZATION OF BARANGAY SECURITY AND TRAFFIC FORCES, GRANTING THEM CERTAIN PRIVILEGES TO INCLUDE THE BARANGAY COUNCIL MEMBERS, SECRETARY, TREASURER, SK CHAIRMAN, APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES";

SECTION 2. A member of Traffic and Security Forces, in case of permanent incapacity or disability or death that occurred while in the performance of duty and whose length of service as hereunder stipulated is entitled to the corresponding benefit, to wit:

SECTION 3. In case of natural death during incumbency, any Traffic and Security Forces member whose length of service as hereunder stipulated is entitled to the corresponding benefit, to wit:

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 6-90 AS AMENDED ENTITLED "AN ORDINANCE AUTHORIZING ORGANIZATION OF BARANGAY SECURITY AND TRAFFIC FORCES, GRANTING THEM CERTAIN PRIVILEGES, APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES".

Provided, that in case of illness, financial assistance is qualified as to severity, to wit:

- a. Moderate Acute - P5,000.00
- b. Moderate Sub-Acute - P10,000.00
- c. Moderate Chronic - P15,000.00
- d. Severe Acute - P20,000.00
- e. Severe Sub-Acute - P30,000.00
- f. Severe Chronic - P40,000.00

For purposes of this section, the following words shall be understood as follows:

- a. Moderate acute - any illness affecting a single organ or system with significant risk of complication to last for less than 3 weeks.
- b. Moderate sub-acute - any illness affecting a single organ or system with significant risk of complication lasting for more than 3 weeks but less than six months.
- c. Moderate chronic - any illness affecting a single organ or system with significant risk of complication lasting for more than six months.
- d. Severe acute - any generalized, multi-organ illness with significant risk of death lasting for less than 3 weeks to less than six months.
- e. Severe sub-acute - any generalized, multi-organ illness with significant risk of death lasting for more than 3 weeks to less than six months.
- f. Severe chronic - any generalized, multi-organ illness with significant risk of death lasting for more than six months.

- g. Medical Abstract - a document issued by the attending hospital physician containing a complete history and physical examination of the patient.

SECTION 4. Benefits specified in Municipal Ordinance No. 6-90 as amended that are due to appointive positions excluding Section 2 and Section 3 hereof are to be qualified by length of service as follows:

A. Percentage of the prescribed benefits while in the performance of duty:

| 1. 1 year and below | - | 20% |
| 2. Above 1 year to 2 years | - | 40% |
| 3. Above 2 years to 3 years | - | 60% |
| 4. Above 3 years to 10 years | - | 80% |
| 5. Above 10 years | - | 100% |

B. Percentage of the prescribed benefits during incumbency:

|------------------------------|---|------|
| 1. 3 years and below | - | 30% |
| 2. Above 3 years to 10 years | - | 70% |
| 3. Above 10 years | - | 100% |

SECTION 5. No claim of herein benefits are to be processed without the following documentary requirements:

- Police Report in case of death or injury incurred in the performance of duty.
- Medical Abstract issued by the attending hospital physician in case of illness to include official receipts of purchased medicines, if any.
- Certification as to the number of years in the service to be issued by hereunder offices:

- DLG Pasig Office
- Barangay Affairs Office



SECTION 6. Effectivity – This Ordinance shall take effect immediately upon its approval.


