BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG IN SESSION DULY ASSEMBLED THAT:

Section 1. IMPOSITION OF FEES – there is hereby imposed a rental fee for the use of Senior Citizen's Multi-Purposes Hall, Park 6 Pavilion at Park 6, Brgy. Kapitolyo, Pasig City;

Senior Citizen's Multi-Purpose Hall – P600.00/ for the first three (3) hours and P100.00 per hour for the next exceeding hours


Park 6 Pavilion – One Thousand Two Hundred Pesos (P1,200.00) for the first three (3) hours and Three Hundred Pesos (P300.00) for the next exceeding hours.


Section 2. PAYMENT – the payment shall be made before the use of the above mentioned facilities.

Section 3. VENUE OF PAYMENT - payment of the above rental fees shall be paid to the Office of the City Treasurer who before accepting payment imposed herein shall require presentation of order of payment to be issued by the Asset and Management Division, City General Services Office.


Section 4. This Ordinance shall take effect after its publication in a newspaper of general circulation.
