AN ORDINANCE AMENDING SECTION 1 PARAGRAPHS A AND B, CHAPTER IV OF ORDINANCE NO. 56, SERIES OF 1993 ENTITLED " AN ORDINANCE PRESCRIBING THE RULES AND REGULATIONS IN OCCUPYING AND USING MARKET STALLS AND PROVIDING PENALTIES FOR VIOLATION THEREOF".

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG IN SESSION DULY ASSEMBLED THAT:

Section 1. Section 1 paragraphs A and B, Chapter IV of Ordinance No. 56, series of 1993 is hereby amended to be read as follows:

CHAPTER IV – PROHIBITION

Section 1. CONSTRUCTING, SELLING AND PEDDLING –

No person, partnership, association or corporation shall be engaged in any of the following activities:

- a.) Selling, peddling, offering for sale any goods, wares or merchandise on the passageways, aisles, vacant spaces, sidewalks, and roadways in the public market and within the area of five hundred (500) meter radius from the market.
- b.) Selling, peddling, offering or exposing for sale outside the public market and within the radius of five hundred (500) meter from the market such as goods, wares, or merchandises regularly sold or which could be purchased inside the public market. **Any construction of building within the five hundred (500) meter radius from the market for the purpose of directly or indirectly selling, peddling, offering for sale any similar goods, wares or merchandise sold or could be purchased in the public market is likewise prohibited.**

Section 2. Provided, however, that all existing commercial and business establishments will not be affected as stipulated in Section 1 of this Ordinance.

Any motion or request for reconsideration of the foregoing prohibition, if any, can only be acted upon depending on the outcome, result or decision made in a public hearing or forum attended by public market vendors called for this purpose.

Section 3. EFFECTIVITY - This Ordinance shall take effect thirty (30) days after its approval.
