**BE IT ORDAINED** by the Sangguniang Panlungsod of Pasig that:

**Section 1.** Section 1 (b) **COVERAGE** will be read as follows:

"All employees of City social Welfare Department (CSWD) personnel involve in rescue operations of street children, vagrants and street families, rescue operations/evacuation/rehabilitation centers and areas declared under the state of calamity or emergency by the President or by the Sangguniang Panlungsod where harm and danger or occupational risks or perils to life exists."

**Section 2. APPROPRIATION** – The amount necessary for the payment of hazard duty shall pay of Five Hundred Pesos (P500.00) per month. **PROVIDED,** However, that employees belonging to the same position classification but actually performing office functions shall be not be eligible to the additional hazard duty pay.

**Section 3. EFFECTIVITY.** This Ordinance shall take effect immediately.
