AN ORDINANCE ADOPTING THE PAMANTASAN NG LUNGSOD NG PASIG (PLP) UNIVERSITY CODE AS A LEGAL AND BINDING INSTRUMENT.

WHEREAS, the promotion and delivery of quality education is among the priority development programs of the City Government of Pasig;

WHEREAS, in line with the said program, the **Sangguniang Panlungsod ng Pasig enacted Ordinance No. 11 series of 1999** creating the Pamantasan ng Lungsod ng Pasig as a coeducational university to meet the increasing demand for education advancement accessible to Pasigueños;

WHEREAS, Section 4 – Powers and Duties of the Governing Boards of Republic Act No. 8292 otherwise known as **AN ACT FOR THE UNIFORM COMPOSITION AND POWERS OF THE GOVERNING BOARDS, THE MANNER OF APPOINTMENT AND THE TERMS OF OFFICE OF THE PRESIDENT OF CHARTERED STATE UNIVERSITYS AND COLLEGES AND OF OTHER PURPOSES**; states: The governing board shall have the following specific powers and duties in addition to its general powers of administration and the exercise of all the powers granted to the board of directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporation Code of the Philippines:

a) to enact rules and regulations not contrary to law as may be necessary to carry out the purposes and functions of the university or college.

WHEREAS, Section 6 Sangguniang Panlungsod ng Pasig Ordinance No. 11 series 1999, likewise states: **The Board shall have the following powers and duties, in addition to the general powers and administration and the exercise of all powers of a corporation as provided in Section 36, Batas Pambansa Bilang 68, otherwise known as the Corporation of the Philippines:**

g) to prescribe rules for its own government and to enact for the Government of the Pamantasan ng Lungsod such rules and regulations not contrary to law as may be necessary to carry out the purposes and functions of the Pamantasan;

AN ORDINANCE ADOPTING THE PAMANTASAN NG LUNGSOD NG PASIG (PLP) UNIVERSITY CODE AS A LEGAL AND BINDING INSTRUMENT.

WHEREAS, in compliance with Section 6.4. of the Commission on Higher Education (CHED), Circular Memorandum Order No. 46, series of 2012, Criteria for Institutional Sustainability Enhancement, on Governance and Management, the PLP must show proof that it has development its own Governance and Management system and provide proof that this has been institutionalized.

WHEREAS, the PLP Board of Regents has approved the University Code comprised of:

- 1.) Governance Manual;
- 2.) Faculty and Administrative Personnel Manual; and
- 3.) Student Manual

for implementation and adoption of the Sangguniang Panlungsod ng Pasig as a legal and binding governance and management instrument of the PLP.

WHEREAS, the provisions of the said University Code were reiterations and/or were derived from the Civil Service Commission Laws, the CHED Law, the GSIS Law, Magna Carta for Public School Teachers, the Family Code, other relevant laws, and policy issuances of the Board of Regents that are not contrary to law.

NOW THEREFORE, BE IT ORDAINED BY THE SANGUNIANG PANLUNGSOD IS SESSION DULY ASSEMBLED:

Section 1. **OBJECTIVE.** – The adoption of the Pamantasan ng Lungsod ng Pasig University Code composed of the Governance Manual, Faculty and Administrative Personnel Manual and the Student Manual as a legal instrument of the Pasig City Government that embodies the rules and regulations which are necessary for the Pamantasan to carry out the purposes and functions of a Higher Education Institution whose provisions were reiterations and/or were derived from Civil Service Commission Law, the CHED Law, the GSIS Law, Magna Carta for Public School Teachers, the Family Code, other relevant laws, and policy issuances of the Board of Regents that are not contrary to law.

Section 2. **ADMINISTRATION** - The administration and implementation of the University Code shall reside upon the Board of Regents and the University Administration.


Section 5. **EFFECTIVITY** - This ordinance shall take effect immediately upon its approval.


