ORDINANCE ABOLISHING VACANT POSITIONS AT PASIG CITY SCIENCE HIGH SCHOOL.

WHEREAS, Section 458 (a) (1) (viii), R.A. 7160 provides that the Sangguniang Panlungsod shall have the power to approve ordinances and pass resolutions to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the conduct of programs, projects, services and activities;

WHEREAS, concomitant with the above-quoted power, the Sangguniang Panlungsod likewise has the power to abolish plantilla positions which are no longer necessary for the operations of offices and departments of the City Government or which plantilla positions remain and continue to remain vacant for several years;

WHEREAS, the vacant positions in the Pasig City Science High School hereunder enumerated are already absorbed and included in the plantilla position of the Department of Education, Culture and Sports;

WHEREAS, the salaries, allowances and other emoluments and benefits that are attached to vacant positions can be channeled or allocated by the City Government to social and health services;

WHEREAS, the abolition of these plantilla positions were discussed in consultation with the officials of the Pasig City Science high School;

NOW, THEREFORE, be it ordained that:

Section 1. COVERAGE – The following vacant positions with the corresponding item member, salary grades, steps and corresponding salaries are hereby abolished:





APPROVED, this 14th day of November 2013 at Pasig City.






