AN ORDINANCE AMENDING ORDINANCE NO. 25, SERIES OF 2013 ENTITLED "ORDINANCE AMENDING ORDINANCE NO. 42, SERIES OF 2011 ENTITLED "AN ORDINANCE OF CLOSED CIRCUIT CAMERAS IN PAWNSHOPS, FINANCING INSTITUTION AND BANKS AND/OR THEIR BRANCHES LOCATED IN PASIG CITY, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES".

NOW, THEREFORE, BE IT ORDAINED that:

Section 1. Section 6 of Ordinance 25, series of 2013 is hereby amended to be read as follows:

"SECTION 6. Implementing Office – The Business Permit and License Office (BPLO) is mandated to make the Implementing Rules and Regulations (IRR) and tasked to conduct random inspections of the business establishments concerned to ensure compliance of this Ordinance. The BPLO shall also take charge of placing stickers at the entrance/exit of said business establishments. Stickers with a phrase: "WARNING: *This establishment is protected by CCTV*". The Command Center and Building Official is hereby tasked to assist the BPLO for the implementation of the IRR."

Section 2. Section 7 of Ordinance No. 25, series of 2013 is hereby amended to be read as follows:

"SECTION 7. COOPERATION AND COORDINATION – The City Government of Pasig, by virtue of its Police Power, can require any establishment to submit copy/s of recorded incident in a multimedia storage like compact disk (CDs) that can be used to solve any crime against lives and properties, the identity of the said establishment shall not be in any way, divulged to anyone for security reasons.

For the purpose of securing Business Permit, the City Government of Pasig through its Business Permit and License Office (BPLO) requires the applicant to present/submit the following documents:

- 1) Affidavit of Compliance of owner/managing partner that the required CCTV system has already been installed in the subject establishment and
- 2) Captured image from the CCTV camera.


Section 3. Section 8 of Ordinance No. 25, series of 2013 is hereby amended to be read as follows:


"SECTION 8. VISITORIAL POWERS OF THE LGU – The City Government of Pasig thru the Business Permit and License Office, pursuant to the provisions of Sec. 16 of RA 7160 also known as "General Welfare – The Local Government Code of 1991", shall exercise the power expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental of its efficient and effective governance, and those which are essential to the promotion of the general welfare xxx shall have visitorial power to ensure compliance, conformity and continuity of the Ordinance from all concerned establishments."


Section 4. Section 7, 8 & 9 of Ordinance No. 25, Series of 2013 are hereby renumbered as 8, 9 and 10.
