AN ORDINANCE APPROPRIATING PORTION OF THE CALAMITY FUND TO GRANT FINANCIAL ASSISTANCE AND EMERGENCY RELIEF TO SISTER CITIES AND MUNICIPALITIES THAT ARE AFFECTED BY CALAMITIES AND DISASTERS.

WHEREAS, Section 16, Chapter II, Book 1 of the Local Government Code of 1991 mandates that every local government unit shall exercise the powers expressly granted, those necessarily implied as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, for humanitarian reasons and in its aim to extend emergency relief to sister cities and other local government units declared under the state of calamity, the City of Pasig aims to address the needs of disaster victims in the form of relief assistance to include relief, rehabilitation, restoration and socio-economic empowerment;

WHEREAS, the emergency relief assistance shall provide temporary respite to those affected sister cities and municipalities in time of great distress while in the process of recovery and rehabilitation.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Pasig, in session assembled do hereby ordained that:

Section 1. A portion of the calamity fund for aid, emergency relief and rehabilitation to sister cities and municipalities affected by the natural calamities or disasters for repair and rehabilitation shall be granted subject to usual auditing and accounting rules.

Section 2. Affected local government units shall submit damage assessment report, rehabilitation and recovery plans and other data on extent of damage and relief measures to support release of financial assistance and emergency relief to be validated and verified by the Pasig City Local Disaster Relief Rehabilitation and Management Office.

Section 3. Implementation of this Ordinance shall be subjected to the Implementing Guidelines of the Executive.

Section 4. All ordinances or issuances of the city or parts thereof that are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

Section 5. This Ordinance shall take effect immediately upon approval.
