AN ORDINANCE CREATING TWO (2) ADDITIONAL POSITIONS OF NUTRITIONIST DIETITIAN I, PRESCRIBING THE SALARY GRADE, QUALIFICATIONS AND APPROPRIATING FUNDS THEREFOR.

WHEREAS, Section 458 (a) (viii) of Republic act 7160 provides that Sangguniang Panlungsod shall determine the position and salaries, wages allowances and other emoluments and benefits of local government officials and employees paid wholly or mainly from City funds and provide for expenditures necessary for the proper conduct of programs projects, services and activities of the City Government;

WHEREAS, the existing plantilla positions on the City Health Office are deemed unsuitable for new entrants in government service who are without previous professional experience;

WHEREAS, non-existence of sufficient position items in the plantilla of the City Health Office has become an obstacle impeding the appointment of qualified professionals;

WHEREAS, the plantilla of the City Health Office must be supplemented to address its inadequate and to become more adaptive to the personnel development agenda of the city government.

NOW, THEREFORE, THE SANGGUNIANG PANLUNGSOD IN SESSION ASSEMBLED:

Section 1. CREATION - There is hereby created Two (2) additional positions of Nutritionist Dietitian I in the plantilla of the City Health Office.

AN ORDINANCE CREATING TWO (2) ADDITIONAL POSITIONS OF NUTRITIONIST DIETITIAN I, PRESCRIBING THE SALARY GRADE, QUALIFICATIONS AND APPROPRIATING FUNDS THEREFOR.

Section 3. APPOINTMENT – Appointees to the positions created in the previous section must be a bonafied residents of the City of Pasig, of Good Moral character, must possess at least the minimum qualifications for the positions he/she will be appointed to based on the qualifications standards of the Civil Service Commission and shall be appointed by the Local Chief Executive.

Section 4. DUTIES AND RESPONSIBILITIES – The Nutritionist Dietitian I shall have the following duties and responsibilities to wit:

1. Plans, implements, monitor and supervise the nutrition program of the barangay assigned to her/his.
2. Acts as the immediate supervisor of the Barangay Nutrition Scholar(s) assigned in his respective barangay.
3. Organizes and conduct continuing education on health and nutrition.
4. Serves as resource person during seminars/training on health and nutrition.
5. Submits reports of accomplishment to the Nutrition Officer III on a regular basis.
6. Coordinates with the Barangay Chairman and other agencies involve in nutrition program.
7. Conducts periodic field visits to monitor the implementation of the barangay nutrition program of his respective catchments areas.
8. Conduct orientations, briefings and trainings for Barangay Nutrition Scholars and Pasig Health Aides in the barangay assigned to him/her.
9. Submits pertinent data, reports of accomplishment to concerned agencies.
10. Establishes linkages; coordinates with government and non-government organization involve in Nutrition Program.
11. Performs other functions as may be required by his immediate supervisor.

Section 5. SALARIES AND WAGES – The salary and wage levels for the newly created positions are based on the corresponding Salary Grade listed in the Qualification Standards of the Civil Service Commission and in accordance with the Salary Schedule for Special Cities.

Section 6. APPROPRIATIONS – There is hereby appropriated the sum of Six Hundred Sixty Twenty One Thousand Two Hundred Twenty Four Pesos and 64/100 (P621,224.64) to cover the payment of the salaries, allowances and annual benefits for period covering a year and succeeding years thereafter. 



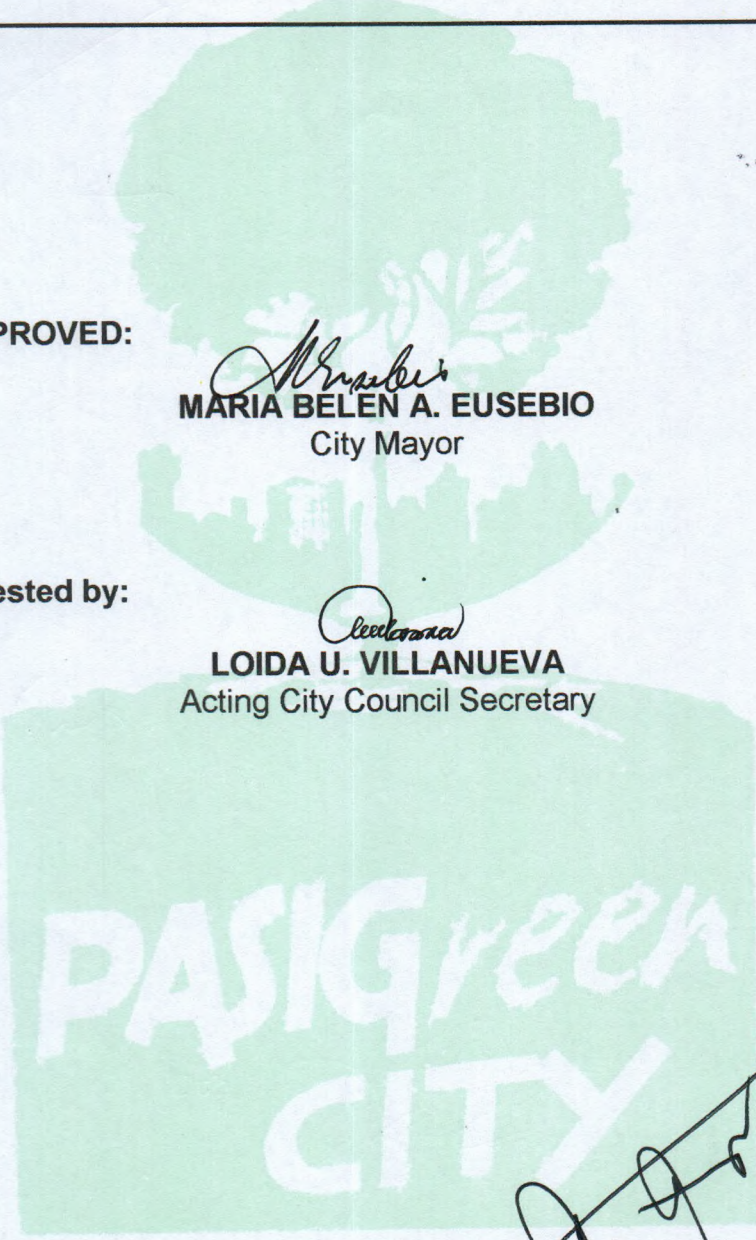
