AN ORDINANCE INCREASING THE ALLOWANCE OF THE BCE SCHOLARS IN THE AMOUNT OF Php134,082,000.00 FOR CY 2014-2015; Php187,932,000.00 FOR CY 2015-2016 AND Php255,371,000.00 FOR CY 2016-2017.

WHEREAS, the City Government of Pasig is committed to provide each year, especially those from indigent families, free access to quality education that will power them to succeed in life;

WHEREAS, the City Government of Pasig has been extending financial support to the poor but deserving Pasigueño student since 1996 by virtue of Ordinance No. 44, series of 1996;

WHEREAS, the City Government of Pasig is likewise responsive of the important role that education plays as a mode of liberating the poor sector of society from the bondage of poverty.

BE IT ORDAINED BY THE CITY OF COUNCIL OF PASIG IN SESSION ASSEMBLED, THAT:

SECTION 1. The amount of Php134,082,000.00 is hereby appropriated to made available for the BCE scholarship program for CY 2014-2015 and shall be taken from the savings or supplemental sources in case of deficiency.

SECTION 2. For CY 2015-2016 the amount of Php187, 932,000.00 and for CY 2016-2017 the amount of Php255,371,000.00 must be allocated for BCE Scholarship Program in the Annual Executive Budget accordingly.

SECTION 3. For the corresponding years after 2017 the amount of Php255,371,000.00 will be allocated for the BCE Scholarship Program incorporated to the Annual Executive Budget unless amended.

SECTION 4. EFFECTIVITY – this ordinance shall take effect upon approval.






