**WHEREAS**, the City Council of Pasig has passed City Ordinance No. 11, series of 2011 establishing the Pasig City Children Hospital and City Ordinance No. 26, series of 2013 naming the newly constructed Hospital in the corner of Alcalde Jose Street and Industria Street, Barangay Kapasigan as Child's Hope Hospital;

**WHEREAS**, there is indeed a need to change the name of the aforementioned hospital for the purpose of appropriate uniformity, recognition, identification and all other legal intentions.

**BE IT ORDAINED BY THE PASIG CITY COUNCIL IN SESSION, ASSEMBLED THAT:**

**SECTION 1.** CHILD'S HOPE HOSPITAL in the corner of Alcalde Jose Street and Industria Street, Barangay Kapasigan, Pasig City is hereby renamed and be known officially as PASIG CITY CHILDRENS HOSPITAL – CHILD'S HOPE.

**SECTION 2.** This ordinance shall take effect immediately upon approval.
