**AN ORDINANCE ESTABLISHING THE PASIG CITY SENIOR CITIZENS WORK FORCE PROGRAM PROVIDING A SYSTEM MECHANISM OR GIVING EMPLOYMENT TO QUALIFIED SENIOR CITIZENS WITH MATCHING SERVICES, AND FOR OTHER PURPOSES.**

**WHEREAS**, Republic Act 9994 or the Expanded Senior citizens Act provides that senior citizens who have the capacity and desire to work or re-employed, shall be provided information and matching services to enable them to be productive members of the society;

**WHEREAS**, the same supports programs to establish a mechanism whereby the contribution of senior citizens are maximized;

**WHEREAS**, local government units are encouraged to create more programs to make their senior citizens more productive;

**WHEREAS**, in its aim to provide employment to senior citizens to help them make use of their experience in their past jobs with skills and qualifications, the city government has proposed an employment program for senior citizens of the City of Pasig emphasizing capability rather than age in hiring them;

**NOW, THEREFORE**, be it **ORDAINED** that:

**SECTION 1. Title** – This Ordinance shall be known as Pasig City Senior Citizens Workforce Act.

**SECTION 2. Purpose** – Pursuant to Article XV, Section 4 of the Constitution, it is the duty of the family to take care of its elderly members while State may design programs of social security for them.

Pursuant to the provision of Republic Act No. 9994, otherwise known as the Expanded Senior Citizens Act, senior citizens who have the capacity and desire to work, or be re-employed, shall be provided information and matching services to enable them to be productive members of society.

**SECTION 3. Qualifications** – Retired professional/non-professional senior citizens who are bonafide members of the Pasig City Federation of Senior citizens and Blue E-Card holder, not a DSWD pensioner and able and physically fit as certified by the City Health Office.

- a) Educators (Teachers)
- b) Doctors / Physicians
- c) Nurses
- d) Midwives
- e) Engineers
- f) Architects
- g) Skilled Workers such as: Finishing Carpenters; electricians; Masons; Machinists; and Welders
- h) Other Professionals/Non-professionals Senior Citizens who are fit to work.


**SECTION 4. Implementing Guidelines** – Implementing Rules, Regulations and Guidelines shall be prepared by the Human Resource Department and Office of the Senior Citizens Affairs of the City.


**SECTION 5. Repealing Clause** – All Ordinances or issuances of the city or parts hereof that are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.




**SECTION 7. Effectivity** - This Ordinance shall take effect upon its approval.






