**AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED TWELVE MILLION EIGHT HUNDRED FOURTEEN THOUSAND SEVEN HUNDRED TWENTY EIGHT PESOS & 48/100 (Php212,814,728.48) FROM FUNDED PURCHASE REQUESTS AND INFRASTRUCTURE PROJECTS UNDER THE GENERAL FUND TO FINANCE OTHER PRIORITY PLANS AND PROGRAMS OF THE CITY.**

**WHEREAS**, the City Government of Pasig has cancelled obligation requests for various purchase request and infrastructure projects in the amount of **TWO HUNDRED TWELVE MILLION EIGHT HUNDRED FOURTEEN THOUSAND SEVEN HUNDRED TWENTY EIGHT PESOS & 48/100 (Php212,814,728.48)** under the General Fund;

**WHEREAS**, there is a need to revert the appropriation of **TWO HUNDRED TWELVE MILLION EIGHT HUNDRED FOURTEEN THOUSAND SEVEN HUNDRED TWENTY EIGHT PESOS & 48/100 (Php212,814,728.48)** in order to finance priority projects, programs and expenditure requirements of the City Government of Pasig for Calendar Year 2014;

**WHEREAS**, the Acting City Budget Officer, City Treasurer and the City Accountant both certified the existence and availability of **TWO HUNDRED TWELVE MILLION EIGHT HUNDRED FOURTEEN THOUSAND SEVEN HUNDRED TWENTY EIGHT PESOS & 48/100 (Php212,814,728.48)** as available source for Supplemental Budget No. 01.

**NOW, THEREFORE**, on motion duly seconded:

**SECTION 1. REVERSION OF FUND** – There is hereby reverted the sum of **TWO HUNDRED TWELVE MILLION EIGHT HUNDRED FOURTEEN THOUSAND SEVEN HUNDRED TWENTY EIGHT PESOS & 48/100 (Php212,814,728.48)** representing the savings of the City of Pasig.

**SECTION 2.** This Ordinance shall take effect immediately.
