**WHEREAS**, Section 17 (2) (xi), R.A. 7160 provides that municipality shall have the power to exercise and discharge such functions, responsibilities, basic services and facilities including tourism facilities and other tourist attraction;

**WHEREAS**, Section 17 (3) (xii), R.A. 7160 likewise provide that a province shall have the power to engage in basic services to include tourism development and promotion program;

**WHEREAS**, Section 17 (4), R.A. 7160 provide that City shall exercise and discharge all the services and facilities of the municipality and province;

**WHEREAS**, Section 18, R.A. 7160 states that local government units shall have the power and authority to create their own sources of revenue and to levy taxes, fees and charges which shall accrue exclusively for their use and disposition and which shall be retained by them.

**NOW, THEREFORE**, BE IT ORDAINED by the Sangguniang Panlungsod that:

**SECTION 1.** The rates of charges for the use of the facilities in the Rainforest Adventure Experience shall be as follows:
