**AN ORDINANCE TO NAME THE BRIDGE CONNECTING LOPEZ JAENA STREET IN BARANGAY SUMILANG AND F. FLORES STREET IN BARANGAY BUTING (SUMILANG-BUTING BRIDGE) AS KAUNLARAN BRIDGE.**

**WHEREAS,** the Local Government Code provides that the territorial and political subdivisions of the State shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals. Toward this end, the State shall provide for a more responsive and accountable local government structure instituted through a system of decentralization whereby local government units shall be given more powers, authority, responsibilities, and resources. The process of decentralization shall proceed from the national government to the local government units.

**NOW, THEREFORE,** on motion duly seconded, the Sangguniang Panlungsod of Pasig, in session assembled do hereby ordained that:

**Section 1.** The newly constructed bridge connecting Lopez Jaena Street in Barangay Sumilang and F. Flores Street in Barangay Buting, Pasig City (Sumilang-Buting Bridge) is hereby named as **Kaunlaran Bridge**.

**Section 2.** Separability Clause – If for any reasons, any part or provision of this Ordinance is held to be unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

**Section 3.** Repealing Clause – Any ordinance, order, memorandum, rule and regulation which is consistent with the provisions of this Ordinance is hereby modified or repealed accordingly.

**Section 4.** Effectivity – This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation within the City.






