**AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE AND/OR EXPROPRIATE WITH VARIOUS PROPERTY OWNERS FOR THE ACQUISITION OF THEIR PROPERTIES THAT WILL BE AFFECTED BY THE WIDENING OF CONDUCTO STREET, BARANGAY CANIOGAN AND BY THE CONSTRUCTION OF BRIDGE ACROSS MARIKINA RIVER AND TO EXERCISE THE POWER OF EMINENT DOMAIN IN CASE NEGOTIATIONS FAIL.**

**WHEREAS**, Section 17 (b) (2) (viii), R.A. 7160 provides that local government units shall likewise such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of the municipal funds including, but not limited to roads and bridges;

**WHEREAS**, Section 17 (b) (4), R.A. 7160 states that all basic services and facilities of the municipality shall also be discharged by the city;

**WHEREAS**, there is a need to decongest the traffic situation in C.Raymundo Avenue and Sixto Antonio by widening Conducto Street in Barangay Caniogan and constructing a bridge across Marikina river passing through the canal beside Mitsubishi Motor in Barangay Ugong to C-5 Avenue;

**NOW, THEREFORE, BE IT ORDAINED** by the Sangguniang Panlungsod in session assembled that:

**Section 1.** The Honorable City Mayor Maria Belen A. Eusebio is hereby authorized to negotiate with various property owners for the acquisition of their properties that will be affected by the widening of Conducto Street, Barangay Caniogan and by the construction of bridge across Marikina River.

**Section 2.** In case the negotiations with the property owners for the acquisition of their properties fail, the City Mayor is hereby authorized to exercise the power of eminent domain.

**Section 3.** The amount to be used for the payment of just compensation shall be taken from the land capital outlay of the City Mayor as provided for in the general appropriation ordinance for CY 2015.

**Section 4.** This Ordinance shall take effect immediately.




