WHEREAS, it is the declared policy of the city government to strengthen and enhance a responsible financial management to ensure sufficient resources to finance socio economic and development programs;

WHEREAS, to assist and advise the City Mayor on budget and finances, there is a need to create a position of Consultant for Budget and related services;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod in a session duly assembled, do hereby ordained that:

SECTION 1. There is hereby created a position of Consultant for Budget and related services, Office of the City Mayor.

SECTION 2. The Consultant for Budget and related services shall perform the following functions in accordance with the vision and mission of the city government:

- a. Provide expertise and assistance in the preparation of a regular and special budgets;
- b. Provide consultancy services in the review of budget proposals of different departments and units of the city government;
- c. Provide assistance in the enhancement of finances through innovative measures such as legislative enactments and executive strategies and directions for an efficient and effective fiscal management;
- d. Provide such other services towards enhancement of city funds in accordance with law and COA policies, rules and regulations.

SECTION 3. The Consultant for Budget and related services shall possess sufficient educational qualifications, skills and experience particularly in the field of budget, assessorial, finance and related services.

SECTION 4. The Consultant for Budget and related services shall receive compensation of Thirty Thousand Pesos (P30,000.00), *provided*, however, he/she is not entitled to other benefits being received and to be received of a permanent city personnel.




