AN ORDINANCE EXPANDING THE BCE SCHOLARSHIP PROGRAM OF THE CITY OF PASIG.

WHEREAS, the City Government of Pasig is committed to provide each year, especially those from indigent families, free access to quality education that will power them to succeed in life;

WHEREAS, the City Government of Pasig has been extending financial support to the poor but deserving Pasigueño student since 1996 by virtue of Ordinance No. 44, series of 1996;

WHEREAS, the City Government of Pasig is likewise responsive of the important role that education plays as a mode of liberating the poor sector of society from the bondage of poverty.

Be it ordained by the City Council of Pasig in Session Assembled, that:

- Section 1. A maximum of 250 students can avail of this program.
- Section 2. He / She must meet the requirements for being a Scholar but was cut off due to point system.
- Section 3. He / She must be a BCE Scholars for at least 2 years before graduating.
- Section 4. He/She will receive 50% of the regular BCE Scholar rate for college.
- Section 5. The amount of Php2,250,000.00 is hereby appropriated for SY. 2015-2016 and Php2,812,500.00 for SY. 2016-2017- onwards.
- Section 6. **Effectivity** - this ordinance shall take effect upon approval.
