AN ORDINANCE FURTHER AMENDING SECTION 1 OF CITY ORDINANCE NO. 32 SERIES OF 2011 AS AMENDED BY ORDINANCE NO. 11 SERIES OF 2012 APPROPRIATING FUNDS FOR THE INCREASE IN MONTHLY ALLOWANCE OF TEACHERS FROM ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) TO THREE THOUSAND PESOS (P3,000.00) OF PASIG CITY SCIENCE HIGH SCHOOL (PCSHS) CHARGE DOT GENERAL FUND

**WHEREAS**, as a premier public science high school, the Pasig City Science High School (PCSHS) aims to provide consistent high quality curriculum and instruction enriched with varied Science and Technology courses;

**WHEREAS**, the proposed granting of increase for the additional allowance for PCSHS teachers is beneficial in line with commitment of the city to ensure that public school teachers are compensated considering the work load they have, the time they spend, the effort they give to their students, and the knowledge and expertise they impart to uplift the country's education;

**WHEREAS**, pursuant to Section 458 of R.A. 7160, otherwise known as the Local Government Code, "The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants and shall: Par. 1 Approve ordinances and pass resolutions for the efficient and effective city government, and in this connection shall: "(xi) When the finances of the city government allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the city.";

**NOW, THEREFORE, BE IT ORDAINED THAT:**

**Section 1.** Section 1 of City Ordinance No. 32 series of 2011 is further amended to be read as follows:

"Teachers (getting salaries from the city government of Pasig) will receive the amount of Three Thousand Pesos (P3,000.00) each as monthly allowance which will be appropriated from the General Fund.

**Section 2.** Effectivity. This ordinance shall take effect upon its approval


