AN ORDINANCE APPROPRIATING THE AMOUNT NECESSARY AS COMPENSATION ADJUSTMENT FOR THE EMPLOYEES OF THE CITY GOVERNMENT OF PASIG, PURSUANT TO EXECUTIVE ORDER NO. 201 OF THE PRESIDENT OF THE PHILIPPINES AND LOCAL BUDGET CIRCULAR NO. 108 OF THE DEPARTMENT OF BUDGET & MANAGEMENT, FUNDS TO BE TAKEN OUT FROM THE APPROVED EXECUTIVE BUDGET CY 2016, THE SALARY SAVINGS AND FROM OTHER SOURCES AVAILABLE IN THE CITY TREASURY, SUBJECT TO ALL LEGAL AND AUDITING RULES AND PROCEDURES.

WHEREAS, the President of the Philippines, issued Executive Order No. 201 mandating a revised compensation and position classification system in the Local Government Units;

WHEREAS, the aforementioned Executive Order states that there is an immediate need to update the compensation structure of the government personnel. Thus, it is imperative to upgrade and further rationalize the present compensation system;

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 108 dated February 24, 2016, specifying the Guidelines necessary for the implementation of the Executive Order;

WHEREAS, it is necessary that an amount be appropriated for the purpose herein stated.

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG, IN SESSION DULY ASSEMBLED THAT:

Section 1. The amount necessary for the implementation of Executive Order No. 201, issued February 19, 2016, is hereby appropriated as compensation adjustment for the employees of the City Government of Pasig and in pursuant to Local Budget Circular No. 108 of the Department of Budget and Management, funds to be taken out from the approved Executive Budget CY 2016, the Salary Savings and from other sources available in the City Treasurer.

Section 2. The City Treasurer and the Budget Officer are hereby directed to implement this Ordinance pursuant to the provisions of the above Executive Order and in accordance with the implementing guidelines issued by the Department of Budget and Management (DBM) Local Budget Circular No. 108 dated February 24, 2016, subject to all legal and auditing rules and procedures.




