AN ORDINANCE CREATING ADDITIONAL CO-TERMINOUS PRIMARILY CONFIDENTIAL POSITIONS IN THE OFFICE OF THE CITY MAYOR, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSE.

WHEREAS, Section 77, RA 7160 otherwise known as the Local Government Code of 1991 provides that the Local Chief Executive of every local government unit (LGU) shall be responsible for human resources development in the local government unit and shall take all personnel action in accordance with the constitutional provisions such policies, guidelines and standards as the Civil Service Commission may establish;

WHEREAS, Section 458 (a) (viii) of Republic Act 7160 provides that the Sangguniang Panlungsod shall determine the position and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the City Government;

WHEREAS, the number of co-terminous primarily confidential positions in the current plantilla the Office of the City Mayor is deemed insufficient to address the needs of the Local Chief Executive for the efficient management of its affairs.

NOW, THEREFORE, the Sangguniang Panlungsod in session duly assembled, do hereby ordained the creation of positions pursuant to Section 458 (1) (viii), R.A. 7160 known otherwise as the Local Government Code of 1991.

BE IT ORDIANED by the City Council of Pasig in session assembled that:

Section 1. CREATION - The following confidential positions co-terminous with the appointing authority are hereby created, to be exempt from the Qualification Standards of the Civil Service Commission and with the corresponding Salary Grade and monthly compensation, viz.:

AN ORDINANCE CREATING ADDITIONAL CO-TERMINOUS PRIMARILY CONFIDENTIAL POSITIONS IN THE OFFICE OF THE CITY MAYOR, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSE.

Section 3. APPOINTMENT - Appointees to the positions created in the preceding section shall be based solely on the trust and confidence of the Local Chief Executive. Appointees shall be expected to serve for the full term of the Local Chief Executive but shall not have security of tenure. Occupants of these positions may be terminated at any time and before the term of the office of the appointing authority ends once trust and confidence are lost. The positions shall be considered confidential in nature when the duties of the said position require the appointing authority's belief that he can share a close intimate relationship with the occupant, which ensures freedom of discussion without fear of embarrassment or possible betrayal of personal trust on confidential matters of state.


Section 4. SALARIES & WAGES - The salary and wage levels for the newly created positions are based on the First Tranche Salary Grades for 1st Class Highly Urbanized Cities under the Salary Standardization Law - IV (SSL-IV).


Section 5. APPROPRIATION - There is hereby appropriated the sum of **FOUR MILLION THREE HUNDRED EIGHTEEN THOUSAND NINE HUNDRED ONE PESOS and THIRTY SIX CENTAVOS (P4,318,901.36)** to cover the payment of salaries, allowances and annual benefits for a period covering a year and succeeding years thereafter.


Section 6. BUDGETARY REQUIREMENT - The funds to implement the provisions of this ordinance shall be charged to the Office of the City Mayor or to any available funds of the city. Provided, the City Mayor may suspend the implementation of non-priority projects to serve as source of funds of this Ordinance, subject to accounting and auditing rules and regulations. Provided, further, that the general limitations prescribed in Section 325 RA7160 are to be strictly observed.


Section 7. EFFECTIVITY - This Ordinance shall take effect upon its approval.
