AN ORDINANCE ESTABLISHING A RECREATION CENTER FOR THE ELDERLY RESIDENTS OF THE CITY OF PASIG, AND FOR OTHER PURPOSES.

WHEREAS, "Section 1. Declaration of Policies and Objectives. – As provided in the Constitution of the Republic of the Philippines, it is the declared policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and an improved quality of life. In the Declaration of Principles and State Policies in Article II, Sections 10 and 11, it is further declared that the State shall provide social justice in all phases of national development and that the State values the dignity of every human person and guarantees full respect for human life";


WHEREAS, consistent with the constitutional principles, this Ordinance is governed by the following objectives:

- (a) To recognize the rights of senior citizens to take their proper place in society and make it a concern of the family, community, and government, and
- (b) To give full support to the improvement of the total well-being of the elderly and their full participation in society, considering that senior citizens are integral part of Philippine society.


WHEREAS, the Local Government Code of 1991 (RA 7160) particularly in Section 458 (a) (5) (xvii), the city is empowered to provide incentives and policies mutually beneficial to the elderly and the community; provide incentives for non-governmental agencies and entities, and subject to the availability of funds, appropriate funds to support programs and projects for the benefit of the elderly.


NOW, THEREFORE, BE IT ORDAINED AS IT HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD, session duly assembled that:


Section 1. TITLE – This Ordinance shall be as the "RECREATION CENTER FOR THE ELDERLY".






AN ORDINANCE ESTABLISHING A RECREATION CENTER FOR THE ELDERLY RESIDENTS OF THE CITY OF PASIG, AND FOR OTHER PURPOSES.

Section 2. DECLARATION OF POLICY – It is hereby declared as a policy of the City of Pasig to provide appropriate elderly care and facility to indigent, underprivileged, abandoned and homeless senior citizens as well as recreational facility to the general elderly population.

Section 3. The hereunder enumerated principles are embedded with the Recreation Center for the Elderly:

- a.) To provide a comprehensive health care for underprivileged, neglected and abandoned senior citizens for the City of Pasig;
- b.) To provide recreational facility for the general elderly population;
- c.) To assist the elderly to attain more meaningful and productive ageing even for a short period;
- d.) To recognize the important role of non-government organization, institutions, senior citizen federations, individuals and the private sector to actively seek partnership to help the plight of our elderly citizens; and
- e.) To encourage the community and every Pasigueño to value the tradition of caring for the elderly and the family as an inviolable social institution.

Section 4. COVERAGE – This Ordinance shall apply to indigent, under privileged, abandoned, neglected and homeless elderly persons as well as the general elderly population of the City of Pasig.

Section 5. IMPLEMENTING RULES AND REGULATIONS – The City Legal Office, Pasig Social Welfare Office, City Health Office and the Barangay Affairs Office in consultation with the different Senior Citizens Associations in the City and hereby tasked to come up, within sixty (60) days upon approval of the Ordinance, with the Implementing Rules and Regulations (IRR) for approval of the City Mayor for the implementation of this Ordinance.

Section 6. SEPARABILITY CLAUSE – If, for any reasons, any part of provision of this Ordinance shall be declared unconstitutional or invalid, other parts or provisions not affected thereby shall continue to be full force and effect.

Section 7. REPEALING CLAUSE – All ordinances or issuances of the City or parts thereof that are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

Section 8. EFFECTIVITY – This Ordinance shall take effect immediately upon approval.
