BE IT ORDAINED, by the City Council of Pasig in session assembled that:

Section 1. Section 1 of City Ordinance No. 26, series of 2007, is hereby amended to be read as follows:

"Section 1. *INCENTIVE AND AWARDS* – It is hereby mandated the annual grant of incentives and awards to directly involved income generating employees and offices which have exceeded the assigned revenue targets provided for under the annual appropriation act."

Section 2. Section 3 of City Ordinance No. 26, series of 2007 is hereby amended to be read as follows:

"Section 3. *APPROPRIATION* – There is hereby appropriated or set aside an amount of ONE MILLION PESOS (P1,000,000.00) annually for incentives and awards."


Section 3. Section 4 of City Ordinance No. 26, series of 2007 is hereby amended to be read as follows:

"Section 4. *REPEALING CLAUSE* – All ordinances or issuances of the City or parts thereof that are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly."


Section 4. *EFFECTIVITY* – This Ordinance shall take effect upon its approval.






