BE IT ORDAINED by the City Council in session assembled that:

SECTION 1. Section 3 of Ordinance No. 25, Series of 2012 is hereby amended to be read as follows:

- "Definition of Terms – the following words are defined as follows, to wit:
- a. Indigent – those who have no visible means of income or whose income will not be sufficient for the subsistence of the family.
 - b. Senior Citizen – refer to any person who is at least sixty (60) years of age.
 - c. Person with Disabilities (PWD) – persons suffering from restriction or different abilities as a result of a mental, physical or sensory impairment to perform an activity in the manner or within the range considered normal for a human being.
 - d. Funeral Service – service provided by Funeral Service Parlors/Establishment for a deceased person that includes but not limited to the costs or expenses of selected Funeral Service Price Matrix Package.
 - e. Funeral Service Price Matrix Package – detailed funeral service with corresponding fees provided by Funeral Service Parlors/Establishment to determine the costs or expenses that is stated in the Contract between the Family/Relatives of the Deceased Person.
 - f. Agent – a person who is employed or an authorized representative of the Funeral Parlor/Establishment that is committed to provide the funeral service or transact business to Client.

SECTION 2. Section 4 of Ordinance No. 25, Series of 2012 is hereby amended to be read as follows:

"Funeral Service Price Matrix of Funeral Establishments – All Funeral Service Establishments Operating in Pasig shall provide their perspective clients a funeral service Price Matrix including an Indigent, Senior Citizen & PWD Funeral Service Package. Selected Matrix of the Client shall be part and parcel of the Contract where Client may affix their signature for and in Conformity.

SECTION 2. Section 5 of Ordinance No. 25, Series of 2012 is hereby amended to read:

a.) "Indigent Funeral Service Package – All Funeral Service Establishments Operating in Pasig City shall require to provide an Indigent Funeral Service Package similar to sample stated above marked as Package 4 & 5 whose amount, composition or content is left to the discretion of the Funeral Service Establishments".

b.) All Senior Citizens and PWDs have the privilege to apply the 20% Discount in whatever chosen Funeral Service Package as mandated by law.

SECTION 3. Section 6 of Ordinance No. 25, Series of 2012 is hereby amended to read:

a.) "Posting of Signage – All Funeral Service Establishments operating in Pasig City shall post conspicuously in ALL Private/Public Hospitals/Clinics and inside their premises a signage in large font containing the following words "FUNERAL SERVICE PRICE MATRIX-PACKAGE ____ (from Selected Package # 1-3)" and that may also

include "INDIGENT FUNERAL PACKAGES (from Selected Package 4-5)" for Indigent Constituents of Pasig; underneath it, its composition or content shall also be described in the said signage, to be followed by smaller font, "per Ordinance No. 25, series of 2012 and Amended as Ordinance No. _____".

- b.) "Posting of Matrix – All Funeral Service Establishments operating in Pasig City shall visibly post all Funeral Service Price Package not only in their parlors/office but in all private and public hospitals or clinics.
- c.) "Price Adjustment – Price Adjustment or changes in the published Price Matrix should be submitted to the City Government seven (7) days before the implementation or posting of a new matrix."

SECTION 4. Section 7 of Ordinance No. 25, Series of 2012 is hereby amended to read:

"Agent – if the Funeral Service Parlor/Establishments employs an Agent or authorized a person to transact business and commit their service to client should perform the following functions:

- a.) He/She must show to his/her prospective client an authentic and certified true copy of the salient features of this Ordinance just like the contents of all the Funeral Service Price Matrix Package and Indigent Funeral Package that is required for posting and should explain it in a simple language understood by an ordinary layperson.
- b.) He/She must not obliged the Client or the family of deceased for an extra service not stated on the Funeral Service Matrix unless necessary and is related to the cause of death involved in any criminal cases. (i.e. Medico Legal Autopsy)".

SECTION 5. Section 8 of Ordinance No. 25, Series of 2012 is hereby amended to read:

"Penalties for violation and Non-Compliance of this Ordinance as well as Unauthorized Tampering of matrix – the following penalties shall remain imposed for anyone who violates the following provisions and for non-compliance of this Ordinance may lead to non-renewal of their Business Permit and Sanitary License. Henceforth, the common trade policy on 'prices subject to change without prior notice' should not be applied and consider in terms of Price Adjustment on Matrix.
