AN ORDINANCE ABOLISHING VACANT POSITIONS IN DIFFERENT OFFICES AND DEPARTMENTS OF THE CITY GOVERNMENT OF PASIG.

WHEREAS, Section 458 (a) (1) (viii), R.A. 7160 provides that the Sangguniang Panlungsod shall have the power to approve ordinances and pass resolutions to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the conduct of programs, projects, services and activities.

WHEREAS, concomitant with the above-quoted power, the Sangguniang Panlungsod likewise has the power to abolish plantilla positions which are no longer necessary for the operations of offices and departments of the City Government or which plantilla positions remain and continue to remain vacant for several years;

WHEREAS, the salaries, allowances and other emoluments and benefits that are attached to vacant positions can be channeled or allocated by the City Government to social and health services;

WHEREAS, the abolition of these plantilla positions were discussed in consultation with the respective chiefs of offices and departments.

NOW, THEREFORE, be it ordained that:

Section 1. COVERAGE. - The following vacant positions with the corresponding item number, salary grades and corresponding salaries are hereby abolished:
