Section 1. Imposition of Fees. – There is hereby imposed fees for the monthly rental of facilities and office space owned by the City Government as follows:

- 4. Xerox - 3,000.00

B. Open Space in the City Hall and other city owned buildings

- 1. ₱300.00 per square meter plus ₱5,000.00 Privilege to Occupy (PTO)
- 2. Electricity:
 - * Without Aircon - ₱ 2,500.00
 - * With Aircon - 3,500.00

- 4. Telephone - 1,000.00

D. MULTIPURPOSE BUILDING

1. Sports Venue

DAYTIME 6AM-5PM	₱100.00 per 2 hours
NIGHT TIME 5PM-12MN	₱200.00 per 2 hours

2. Socials

Birthday and Baptismal	₱3,000.00 per 4 hours
	₱500.00 succeeding hour
Debut and Wedding	₱3,500.00 per 4 hours
	₱500.00 succeeding hour

Note: Fraction of an hour is computed as a whole.

Section 2. Payment. – The payment shall be made within the first five (5) days of the month or five (5) days prior to actual use without demand with a surcharge of 2% per month or 2% per day whichever is applicable in case of default.

Section 3. Venue of Payment. – Payment of monthly rental fee or days of use to the Office of the City Treasurer who before accepting payment imposed herein shall require presentation of Order of Payment to be issued by the Asset Management Division, City General Services Office or the appropriate Head of Office whichever is applicable.


