WHEREAS, the Batas ng Ciudad Enforcement Office (BCEO) was created under the Office of the Mayor to execute and enforce city ordinances and resolutions within the jurisdiction of the city;

WHEREAS, to promote the general welfare, comfort and convenience of the community, the City of Pasig has passed several city ordinances and resolutions to safeguard and preserve peace and order, protect life and property and preserve public order;

WHEREAS, peace enforcers are tasked to assist the police force and persons in authority in its drive to repress criminality and violators of local laws;

WHEREAS, when public interest requires, the BCEO or City Ordinance Police (COP) coordinates with local police and barangay peace enforcers in enforcing peace and order and implementation of policies within the city;

NOW THEREFORE, BE IT ORDAINED, by the City Council of Pasig, in session duly assembled that:

SECTION 1. Section 4 of Ordinance No. 04 Series of 2006 is hereby amended to be read as follows:

SECTION 4. DUTIES AND RESPONSIBILITIES – The following are the duties and responsibilities of the Batas ng Ciudad Enforcement Office.

- A. The Batas ng Ciudad Enforcement Office (BCEO) composed of City Ordinance Police (COP) is mainly tasked to enforce, implement and monitor compliance to city ordinances and resolutions.
- B. The COP shall coordinate with Barangays and Police Community Precincts in the implementation of local laws, ordinances, resolutions and assist in the apprehension of violators.

The COP shall assist City Departments and Offices in the enforcement of their programs, projects and activities.

The COP shall assist in special operations of the City and shall perform additional tasks as may be assigned from time to time by the City Mayor.

SECTION 2. REPEALING CLAUSE. All Ordinances or issuances of the City or parts thereof that are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 3. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
