AN ORDINANCE ESTABLISHING THE PASIG PRIVILEGE CARD IN THE CITY OF PASIG AND FOR OTHER PURPOSES.

WHEREAS, it is the policy of the state to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

WHEREAS, the City Government of Pasig through the Pasig Research Center (PRC) established a census data gathering scheme utilizing the Community-based Monitoring System (CBMS) as a monitoring tool in the implementation of local development plans;

WHEREAS, the City Government of Pasig provides various programs benefitting its constituents;

WHEREAS, to provide residents of Pasig City with means to transact business and avail of basic social and other services for education, livelihood, health, security and safety, a city identification card system is proposed to harmonize relevant transactions;

WHEREAS, a computerized database system to properly identify residents of Pasig for registration will be established through a PASIG PRIVILEGE CARD;

NOW, THEREFORE, be it Ordained that:

SECTION 1. TITLE. – This Ordinance shall be known as the Pasig Privilege Card

SECTION 2. OBJECTIVES. – This Ordinance aims to:

- Provide and maintain a medical database which will contain basic and necessary information of each resident to be used for medical and basic health care services;
- Help facilitate access to basic social and other services in government as well as in private establishments;
- Help establish the identity of residents in the city availing themselves of basic services and programs for Pasigueños.

SECTION 3. COVERAGE. – All bonafide residents 18 years old and up to 59 years old may avail of the PASIG PRIVILEGE CARD system.

SECTION 4. DATA REQUIRED FOR PASIG PRIVILEGE CARD APPLICANTS. – The data to be recorded shall be limited to the following:

1. Name
2. Address
3. Voter's Identification Number
4. Community Tax Number (Cedula)

Applicants shall:

1. Fill up application form
2. Present any valid ID to verify residency
3. Present photocopy of Birth Certificate

SECTION 5. ENTITLEMENT TO BENEFITS. – Subject to limitations specified by this Ordinance and as may be determined by the Barangay Affairs Office, the following shall be made available to holders of PASIG PRIVILEGE CARD:

- a. 20% discounts in:
 - i. Selected services at Pasig City General Hospital (PCGH)
 - ii. Selected services at Pasig City Children's Hospital (PCGH)
 - iii. Services at the CHAMP
 - iv. Services at the Rizal Medical Center (RMC)
 - v. Services at the Super Health Centers
- b. Free services in City Government projects such as:
 - i. Project Damayan
 - ii. Check up in Medical Missions and Superlingap Activities
 - iii. Anti-Flu and pneumococcal vaccines
 - iv. Services for new born screening (first child)
 - v. Check-Up for pregnant mothers
 - vi. Anti-Rabies vaccines
 - vii. Livelihood skills training
- c. 20% discounts for birth registration (first child)

- d. 20% discounts in minor traffic violations with TPMO and TORO offices.
- e. 20% discounts in selected facilities at RAVE Park.

Member beneficiaries must renew their cards every January of each year. Late renewal shall be charged Five Hundred Pesos as penalty.

SECTION 6. The City Mayor is hereby authorized to grant discounts specified in Section 5.

SECTION 7. APPROPRIATION. – the amount of Six Million Pesos (P6,000,000.00) is hereby appropriated for this project.


SECTION 8. SEPARABILITY CLAUSE. – If any provision of this ordinance is declared unconstitutional or invalid, the provisions not affected thereby shall continue to be in full force and effect.

SECTION 9. REPEALING CLAUSE. – All Ordinances or issuances of the City or parts thereof that are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.


SECTION 10. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.




