AN ORDINANCE CREATING THE POSITION OF CONSULTANT ON FISCAL AFFAIRS AND ITS RELATED SERVICES IN THE CITY OF PASIG.

WHEREAS, it is the declared policy of the state to strengthen and instill fiscal discipline in the public sector along the principle of responsible financial management in order to ensure sufficient resources to finance socio-economic development programs;

WHEREAS, to assist and advice the Local Chief Executive on local budget and finances, evaluate resources, advise on additional resource and develop financial and tax strategies, there is a need to engage the services of a Consultant on Fiscal Affairs and its Related Services;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod in session duly-assembled do hereby ordain that:

Section 1. There is hereby created the position of Consultant for Fiscal Affairs and Related Services, under the Office of the City Mayor.

Section 2. The Consultant for Fiscal Affairs and Related Services shall provide expertise and assistance to the Local Chief Executive (LCE) in reviewing proposed tax measures of various income-generating departments in the city government in accordance with the plans and programs of the city government.

Section 3. The Consultant for Fiscal Affairs and Related Services shall possess sufficient educational qualifications, skills, professional experience in the field of fiscal management in government.

Section 4. The Consultant for Fiscal Affairs and Related Services shall receive a monthly compensation of Thirty Thousand Pesos (Php30,000.00) but shall otherwise be non-entitled to other benefits being received and to be received by organic personnel of the city government.

Section 5. The tenure of office of the Consultant for Fiscal Affairs and Related Services shall be for a period of one year, extendable thereafter subject to the pleasure and discretion of the City Mayor but in no case shall exceed two (2) years.

Section 6. This Ordinance shall take effect immediately.
