WHEREAS, there has been a formal request from the Day Care Sector for the creation of permanent positions for eighty seven (87) casual Day Care teachers under the Day Care Service of the Pasig Social Welfare and Development Office, which have been noted as indispensable and necessary ;

WHEREAS, the eighty seven (87) casual Day Care teachers have been working with the City Government of Pasig for the Past Twenty (20) years as Day Care workers holding casual positions;

WHEREAS, one of the roles of Day Care teachers is to ensure the provision of care, education, health, nutrition and protection to children aged 0 to 6 is continuously part and an significant foundation for lifelong learning;

WHEREAS, the request for the creation of plantilla positions is crucial in the realization of the City Government's thrust of promoting the interest and welfare of Pasigueños by continuously providing support to the implementation of early childhood development programs among others;

NOW THEREFORE, BE IT ORDAINED THAT:

Section 1. The following Plantilla positions in are hereby created:

Section 2. The budget for salaries and other benefits of the appointees to the aforementioned plantilla positions shall be taken from the approved 2017 Executive Budget of the City Government of Pasig.

Section 3. The Ordinance shall take effect immediately upon its approval.

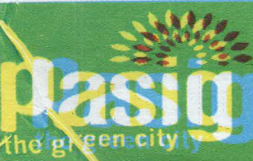
