AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR ROBERT C. EUSEBIO TO NEGOTIATE AND/OR INITIATE EXPROPRIATION PROCEEDINGS FOR THE ACQUISITION FOR PUBLIC USE OF A PARCEL OF LAND COVERED BY TAX DECLARATION NO. E-003-0007 WITH AN AREA OF SIX HUNDRED (600) SQUARE METERS UNDER THE NAME OF CARLOS L. ASUNCION, TO BE USED FOR THE CONSTRUCTION OF A MULTI-PURPOSE BUILDING IN BRGY. BAGONG KATIPUNAN.

WHEREAS, there is an urgent need for the City Government of Pasig to construct a multi-purpose building Barangay Bagong Katipunan for the benefit of the residents and community of Barangay Bagong Katipunan;

WHEREAS, under Section 19 of the Republic Act No. 7160 or the Local Government Code of the Philippines, "a local government unit, may through its Chief Executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose or welfare for the benefit of the general welfare upon payment of just compensation, pursuant to provisions of the Constitution and pertinent laws";

BE IT ORDAINED, by the Sangguniang Panlungsod of Pasig in session assembled that:

Section 1. The City Mayor is hereby authorized to negotiate and/or initiate expropriation proceedings pursuant to Section 19 of Republic Act No. 7160 or the Local Government Code, for the acquisition for public use of a parcel of land covered by Tax Declaration No. E-003-00007 under the name of Carlos L. Asuncion, including the improvements found thereon, to be affected by the construction of a multi-purpose building in Barangay Bagong Katipunan.

Section 2. The City Mayor and the City Treasurer are hereby authorized to deposit in court fifteen percent (15%) of the fair market value of the property sought to be expropriated based on the current tax declaration or so much amount as may necessary to be determined by the proper court or by the City Appraisal Committee in the case of negotiated sale, chargeable against the LAND and LAND IMPROVEMENTS capital outlay budget for the year 2017 in the Office of the City Mayor; subject to COA accounting rules and regulations.

Section 3. The City Mayor is further authorized to pay just compensation for the actual parcel of land including its improvements or structures affected by the project, in accordance with the recommendation of the City Appraisal Committee, subject to existing COA accounting and regulations.
