AN ORDINANCE GRANTING PRIVILEGES TO BARANGAY COUNCIL MEMBERS, SECRETARY, TREASURER, LUPONG TAGAPAMAYAPA, BARANGAY MAINTENANCE, BARANGAY STAFF AND REGULAR AND VOLUNTEER MEMBERS OF THE FOLLOWING; BARANGAY SECURITY FORCES, BARANGAY TRAFFIC ENFORCERS AND FIRE AND RESCUE PERSONNELS, APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES.

WHEREAS, Barangay Community Brigades have been proven to be effective auxiliary groups for beautification, health, sanitation, peace and order, rescue and relief operations, traffic management and other developmental programs;

WHEREAS, Section 16 of R.A. 7160 otherwise known as the Local Government Code mentions the power to appropriate for efficient and effective governance essential to the promotion of the general welfare;

WHEREAS, in recognition of the active participation, fruitful contribution, constructive role played by Barangay Council members, Secretary, Treasurer, Lupong Tagapamayapa, Barangay Maintenance, Barangay Staff and regular and volunteer members of the following; Barangay Security Forces, Barangay Traffic Enforcers and Fire and Rescue Personnel deemed proper, logical, moral and necessary to vest privileges to them as a sign of recognition to their performance and discharge of their functions and duties;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of Pasig City, in session assembled, that:

SECTION 1. Title. This Ordinance shall be known as the Barangay Personnel Incentive of 2017.

SECTION 2. Those personnel included, in case of permanent incapacity or disability or death that occurred while in the performance of duty and whose length of service as hereunder stipulated is entitled to the corresponding benefit, to wit:

SECTION 3. In case of natural death during the incumbency, any member as specified whose length of service is hereunder stipulated is entitled to the corresponding benefit, to wit:

Provided, that in case of illness, maximum financial assistance is qualified as to severity, to wit:

| c. Moderate Chronic | - | P15,000.00 |
| d. Severe Acute | - | P20,000.00 |

| f. Severe Chronic | - | P40,000.00 |

For purpose of this section, the following words shall be understood as follows:

| a. Moderate Acute | - any illness affecting a single organ or system with significant risk of complication to last for less than 3 weeks. |
| b. Moderate Sub-Acute | - any illness affecting a single organ or system with significant risk of complication lasting for more than 3 weeks but less than six months. |
| c. Moderate Chronic | - any illness affecting a single organ or system with significant risk of complication lasting for more than six months. |
| d. Severe Acute | - any generalized, multi-organ illness with significant risk of death lasting for more than 3 weeks to less than six months. |
| e. Severe Sub-Acute | - any generalized, multi-organ illness with significant risk of death lasting for more than 3 weeks to less than six months. |
| f. Severe Chronic | - any generalized, multi-organ illness with significant risk of death lasting for more than six months. |

- g. Medical Abstract - a document issued by the attending hospital physician containing complete history and physical examination of the patient.

SECTION 4. No claim of herein benefits for the legal claimants are to be processed without the following documentary requirements:

- a) Police Report in case of death or injury incurred in the performance of duty.
- b) Medical Abstract issued by the attending hospital physician in case of illness to include official receipts of purchased medicines, if any.
- c) Certification as to the number of years in the service to be issued by hereunder offices:
 - 1) DILG Pasig Office
 - 2) Barangay Affairs Office
 - 3) COMELEC (in case of Elected Officials)

SECTION 5. All Barangay should provide a complete list of their plantilla positions to the Barangay Affairs Office (BAO) within approval of this Ordinance. Also, it is the duty and responsibility of the Barangay to update the list of the Plantilla positions if there are any changes to their corresponding personnel.

SECTION 6. The budgetary requirement to implement this Ordinance shall be chargeable to any available funds at the City Treasury subject to existing Commission on Audit (COA) Rules and Regulations.

SECTION 7. Separability Clause. If any provision of this Ordinance is declared unconstitutional or invalid, the provisions not affected thereby shall continue to be in full force and effect.

SECTION 8. Repealing Clause. All ordinance or issuances, or parts thereof, by the City Government, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 9. Effectivity. This ordinance shall take effect immediately upon its approval.
