AN ORDINANCE ORGANIZING AND ESTABLISHING THE PASIG CITY PERSONS WITH DISABILITY AFFAIRS OFFICE (PC-PDAO) AND FOR OTHER PURPOSES.

WHEREAS, Article XIII, Section 11 of the 1987 Constitution provides that the state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential, good health and other social services available to all people at affordable cost and that there shall be priority for the needs of the underprivileged, sick, elderly, disabled, women and children;

WHEREAS, Article XIII, Section 13 of the 1987 Constitution provides that the state shall establish a special agency for persons with disability for their rehabilitation, and self-reliance and their integration in to the mainstream of society;

WHEREAS, Section 40 (b) (1) of Republic Act No. 7277, otherwise known as the "Magna Carta for Persons with Disability", as amended by Republic Act No. 10070, requires the organization and establishment of a Persons with Disability Affairs Office in all local government units, which shall be the lead office in the enhancement of the health, physical fitness and economic and social well-being of persons with disabilities (PWDs) within the territorial jurisdiction of the establishing local government;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that local government units shall ensure and support the promotion of health and safety, enhance economic prosperity and social justice and preserve the comfort and convenience of their inhabitants;

WHEREAS, the City Government has enacted City Ordinance No. 43, series of 2008, recognizing the rights of Persons with Disabilities, granting privileges and benefits;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL IN SESSION ASSEMBLED:

SECTION 1. Title – This Ordinance shall be known as Pasig City Persons with Disability Affairs Office, PC-PDAO

SECTION 2. Declaration of Policy

- a) Pasig City Government shall give full support to the improvement of the total well-being of PWDs and their integration into the mainstream of society, thus, ensuring their rehabilitation, self-development and self-reliance. It shall develop their skills and potentials to enable them to have equal opportunities available.
- b) Pasig City recognizes the right of the PWDs as other people to have their place in society. They should be able to live freely and independently as possible.
- c) The Local Government of Pasig City likewise recognizes the role of private sector in promoting the welfare of PWDs and shall encourage partnership in programs that address their needs and concerns.

SECTION 3. CREATION. There shall be created the Pasig City Persons with Disability Affairs Office (PC-PDAO)

SECTION 4. FUNCTIONS. – The Pasig City Persons with Disability Affairs Office shall have the following functions:

- a) Formulate and implement policies, plans and programs for the promotion of the welfare of PWDs in coordination with the Pasig City Social Service Office, the National Council on Disability Affairs and the Office of the City Mayor;
- b) Monitoring and implementation of the provision of Republic Act 7277, Batas Pambansa Blg. 344, otherwise known as the Accessibility law, and other relevant laws at the local level;
- c) represent PWDs in meetings of local development council and other special bodies;
- d) Gather complete and relevant data on PWDs in the Barangays;
- e) Disseminate all information regarding employment opportunities for PWDs in the locality;
- f) Submit reports to the office of the Local Chief Executive on the implementation of programs, plans and services for the promotion of the welfare of PWDs;

- g) Perform such other functions as may be necessary for the promotion and protection of the welfare of the PWDs in Pasig City;

SECTION 5. COMPOSITION

The Pasig City Persons with Disability Affairs Office (PC-PDAO) shall be composed of:

- a) Project Development Officer IV
 b) Administrative Aide V
 c) Administrative Aide III

SECTION 6. APPROPRIATION. The annual budget of the City starting the year 2018 shall provide funds for the salaries of the PC-PDAO Office Personnel, in PWD-oriented projects and is day-to-day operations, subject to budgetary limitations under the Local Government Code, Republic Act 7277 and other pertinent laws.

SECTION 7. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared unconstitutional or invalid, the provision not affected thereby shall continue to be in full force and effect.

SECTION 8. REPEALING CLAUSE. All ordinances, rules and regulations or part thereof, in conflict with or inconsistent with any provision of the Ordinance are hereby repealed or modified accordingly.






