WHEREAS, Section 1 of Ordinance No. 07 Series of 2016, states that:

Section 1. The City Mayor is hereby authorized to negotiate and/or initiate expropriation proceedings pursuant to Section 19 of Republic Act No. 7160 or the Local Government Code, for the acquisition for public use of a parcel of land covered by Transfer Certificate of Title No. _____ under the names of _____, including the improvements found thereon, to be affected by the construction of the Pinagbuhatan-Kalawaan Bridge across Napindan River for the benefit of the community and residents of Barangays Pinagbuhatan and Kalawaan.

WHEREAS, there is a need to amend said Section 1 of Ordinance No. 07, Series of 2016.

NOW THEREFORE, BE IT ORDAINED, by the City Council of Pasig in session assembled that:

SECTION 1. Section 1 of Ordinance No. 07, Series of 2016 is hereby amended to be read as follows:

Section 1. The City Mayor is hereby authorized to negotiate with various property owners for the acquisition of their respective properties or only portions thereof, as may be recommended by the Office of the City Engineer, for the construction of a bridge across Pasig River and the necessary road right of way connecting Barangays Pinagbuhatan and Kalawaan of this City. For this purpose, the City Mayor may delegate and/or authorize the Office of the City Legal Officer-Pasig City to represent him or the Office of the City Mayor to make the written offers and negotiate with the affected property owners.




