**AN ORDINANCE AMENDING SECTION 1 AND 2 OF ORDINANCE NO. 09, SERIES OF 2014, INCREASING THE ANNUAL FINANCIAL ASSISTANCE TO THIRTY (30) BARANGAYS OF PASIG CITY IN THE PRESERVATION OF PEACE AND ORDER IN EVERY BARANGAY, AND FOR OTHER PURPOSES.**

**WHEREAS**, the increase in the price of oil and wages of laborers have a domino effect to the cost of commodities, supplies and materials and increase in the operational cost of public and private entities;

**WHEREAS**, there is a need to increase the financial assistance presently extended to all the barangay of the City to perform effectively its task in the preservation of peace and order within its area of responsibility;

**NOW THEREFORE**, the City Council of Pasig in session duly assembled do hereby ordained that:

**SECTION 1.** Section 1 and 2 of Ordinance No. 09 Series of 2014 is hereby amended to be read as follows:

**Section 1.** The City Mayor shall extend financial grant annually to thirty (30) barangays of Pasig as assistance in the preservation of peace and order in every barangay

**Section 2.** The amount of Thirty Three Million, Four Hundred Eighty Thousand Pesos (P33,480,000.00) is hereby set-aside for the implementation of this Ordinance chargeable against any available funds of the City effective January 1, 2018 as the annual assistance to Barangays for peace and order. Said amount may be increased by the City as public interest dictates and subject to the availability of funds.

**Section 2. This Ordinance shall take effect on January 1, 2018.**
