BE IT ORDAINED by the City Council of Pasig, in session duly assembled that:

SECTION 1. Section 124 of Ordinance No. 23 Series of 2016 is hereby amended to be read as follows:

Section 124. Incentives to Enforcement Units and Enforcers.-For all the collected traffic penalties attributed to the issuance of UOVRs, a Twenty One and a half Percent (21.5%) incentive shall be paid as follows:

- a) Fifteen Percent (15%) of the total collections shall be given to all traffic enforcers duly deputized by the Pasig City Government based on the actual apprehensions.
- b) Five Percent (5%) of the total collections shall be for the operational expenses of the office (TPMO). The fund shall be disbursed only for the improvement, activities and requirements of the Traffic and Parking Management Office (TPMO) including the maintenance of its facilities and Traffic Control Devices, raincoats and related supplies excluding salaries of personnel. Any balance of the Twenty One and a half Percent (21.5%) at the end of the year shall revert to the General Fund.
- c) One and a half percent (1.5%) of the total collections shall be divided equally among the officials herein below enumerated including the Chief TPMO or any person designated as Head of the Office.
 - i) Assistant Chief for Administration
 - ii) Assistant Chief for Operation
 - iii) Head, Traffic Enforcement Division
 - iv) Head, Traffic Engineering Division
 - v) Head, Facility Management Division
 - vi) Head, Administrative Complaint Investigation and Adjudication Service
 - vii) Head, Special Motorcycle/Mobile Action Response Team (SMART)
 - viii) Head, District 1 Operation
 - ix) Head, District 2 Operation
 - x) Head, Sector 1
 - xi) Head, Sector 2 / Central Business District (CBD)
 - xii) Head, Sector 3

SECTION 2. Effectivity - This ordinance shall take effect upon its approval.
