**AN ORDINANCE PROVIDING INCENTIVES TO ALL DEPUTIZED ENFORCERS OF THE CITY GOVERNMENT IN ALL THIRTY (30) BARANGAYS OF PASIG CITY FOR THE IMPLEMENTATION OF ALL ORDINANCES OF THE CITY.**

**WHEREAS**, Section 16 of R.A. 7160 otherwise known as the Local Government Code mentions the power to appropriate for efficient and effective governance essential to the promotion of the general welfare;

**WHEREAS**, in recognition of the active participation and contribution of the deputized enforcers, the City Government of Pasig will provide incentives to them as a sign of recognition to their performance and discharge of their functions and duties;

**WHEREAS**, the deputized enforcers in all thirty barangays will served as a multiplying force by the City Government that will be able to give quality and faster service to the people of Pasig;

**NOW, THEREFORE**, be it **ORDAINED** by the **SANGGUNIANG PANLUNGSOD**, in session duly assembled that:

**SECTION 1. TITLE** – This Ordinance as “Incentives to Deputized Enforcers in the Barangays”.

**SECTION 2. INCENTIVES**

- a) Fifteen Percent (15%) of the collected fines shall be for the deputized enforcers in the barangays. Operation should be done only within their jurisdiction.
- b) Fifteen Percent (15%) of the collected fines shall be for the administrative expenses of the concerned barangay. The funds shall be disbursed only for the maintenance of peace and order.
- c) The balance of Seventy Percent (70%) will go to the general fund of the City Government.
- d) All the enforcers and personnel are to be designated by the City Mayor or his authorized representative prior to the entitlement to the foregoing incentives.

**SECTION 3. EFFECTIVITY** - This ordinance shall take effect upon its approval.


