AN ORDINANCE AMENDING CITY ORDINANCE NO. 01, SERIES OF 2013 "AN ORDINANCE PROHIBITING THE DRINKING OF BEER, LIQUOR OR OTHER ALCOHOLIC OR INTOXICATIVE BEVERAGES IN "SARI-SARI STORE, STREET, SIDEWALK, ALLEY, CALLEJON, PARK, PLAZA OR OTHER SIMILAR PUBLIC PLACES".

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD NG PASIG IN SESSION ASSEMBLED.

SECTION 1. No person shall drink, partake or otherwise imbibe beer, liquor or other alcoholic or intoxicative beverages in "Sari-sari" store, public street, sidewalk, park, plaza, square, parkway, alley, "callejon" or other similar public places;

"Other similar public places" shall include those privately owned compound without any fence and visible outside public view.

SECTION 2. In celebration of public events like Independence Day, Liberation day, Barangay Day, feasts or other similar public occasions, persons or groups of persons may drink, partake or other imbibe beer, liquor or other alcoholic intoxicating beverages in a public park, plaza, square or similar public places provided that a previous permit shall have been first applied for and issued by the Mayor or his duly authorized representative for the use of such public place or places for the celebration of said public events; the permit is only up to ten (10) o'clock in the evening.

SECTION 3. On the occasion of family celebrations like weddings, birthdays, anniversaries, reunion or other similar family gatherings, a portion of the sidewalk or public place adjacent to the house/place where the celebration is being observed may be used/ and beer, liquor or other alcoholic or intoxicating beverages may be served without incurring any liability whatsoever under the provisions of this ordinance, provided however, that a prior permit shall be applied for and issued by the Mayor, Barangay Chairman or duly authorized representative for the use of such sidewalk or public place; permit to be issued shall be until ten (10) o'clock in the evening.

SECTION 4. It is unlawful that any person found drinking, partaking or otherwise imbibing beer, liquor or other alcoholic or intoxicating beverages on 'sari-sari" store, public street, sidewalk, park, plaza, square, parkway, alley, "callejon", or other similar public places without falling under the exceptions provided for in Section 2 and 3 hereof, shall be penalized.

AN ORDINANCE AMENDING CITY ORDINANCE NO. 01, SERIES OF 2013 "AN ORDINANCE PROHIBITING THE DRINKING OF BEER, LIQUOR OR OTHER ALCOHOLIC OR INTOXICATIVE BEVERAGES IN "SARI-SARI STORE, STREET, SIDEWALK, ALLEY, CALLEJON, PARK, PLAZA OR OTHER SIMILAR PUBLIC PLACES".

SECTION 5. Establishments who are authorized by the Business Permit and Licensing Office (BPLO) to sell and consume the liquor in the said establishment is exempted from this Ordinance.

SECTION 6. PENALTIES

First Offense: Fine of Five Hundred Pesos (P500.00) or four (4) hours community service.

Second offense: Fine of One Thousand Pesos (P1,000.00) or eight (8) hours community service.

Third Offense: Fine of Two Thousand Pesos (P2,000.00) or sixteen (16) hours community service and imprisonment of not less than one (1) month or not less than three (3) months or both at the discretion of the court.

SECTION 7. IMPLEMENTING AUTHORITY – Any of the following offices is tasked to strictly implement this Ordinance.

The Office of Public Safety (OPS), the Batas ng Ciudad Enforcement Office (BCEO), the Philippine National Police, Pasig City Task Force Disiplina and Barangay Officials and Security Forces (BSF).

SECTION 8. DATA BASE COMPUTER RECORDING

The implementing agencies should maintain a Data Base System of the violations being committed with regards to this Ordinance in order to determine the frequency of individual violations.

SECTION 9. NO CONTEST PROVISION. Any person, individual or entity who is apprehended or sited for violation and who does not wish to contest the violation and is willing to pay voluntarily the minimum fine imposed upon him/her prior to the filing of formal charges with the proper court shall be allowed to pay said fine with the City Treasurer to avoid being criminally prosecuted within Forty Eight (48) hours from apprehension, otherwise the case shall be prosecuted.

SECTION 10. The City Treasurer or any designated officer, subject to civil service laws, rules and regulations is hereby directed to provide personnel who will accept payment of fines twenty four (24) hours a day so as not to jeopardize the right of the offended to avail of the Forty Eight (48) hours within which to pay under this ordinance.

SECTION 11. SEPARABILITY CLAUSE.

If, for any reason, any part or provision of this ordinance shall be declared unconstitutional or invalid, other parts or provisions not affected thereby shall continue to be in full force and effect.

SECTION 12. REPEALING CLAUSE. All ordinances or issuances of the City or parts thereof that are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.

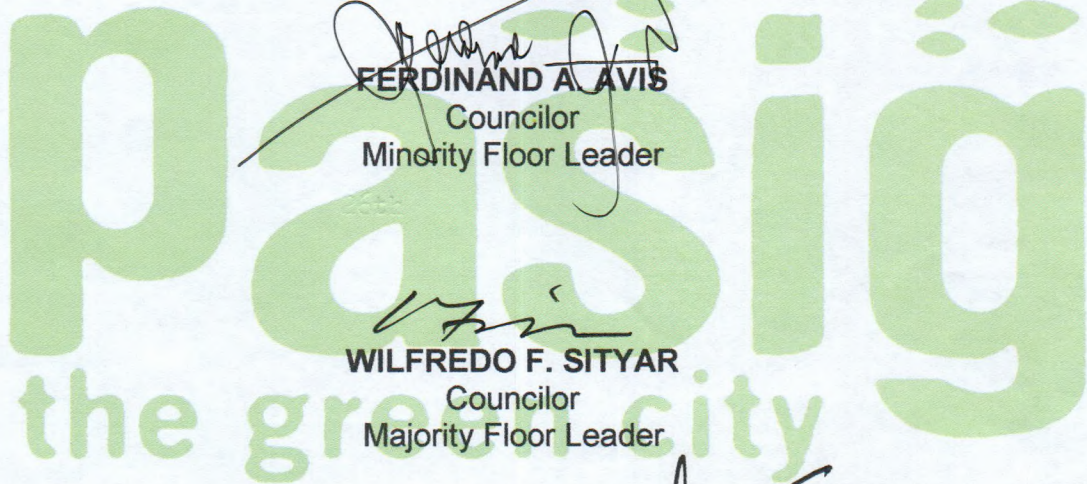
