AN ORDINANCE CREATING CONSULTANCY POSITIONS FOR EDUCATION.

WHEREAS, Section 458 (a) (1) (viii) of the Local Government Code provides that the Sangguniang Panlungsod is empowered to determine the position and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

WHEREAS, Section 77 of the Local Government Code states that "the chief executive of every local government unit shall be responsible for human resources and development in his unit and shall take all personnel actions in accordance with the Constitutional provisions on civil service, pertinent laws, rules and regulations thereon, including such policies, guidelines and standards as the Civil Services Commission may establish;

WHEREAS, to assist and advice the Local Chief Executive on strategies to help raise the quality of education in all public schools in line with the K to 12 program, there is a need to hire education consultants;

WHEREAS, these education consultants will undertake research and provide recommendations on curriculum development, improve academic proficiency of students as well as introduce training courses to enhance teaching capabilities of instructors.

NOW, THEREFORE, BE IT ORDAINED THAT:

SECTION 1. The following consultancy positions are hereby created with the following allowances in the amount of P10,000.00 for each positions:

- (2) Consultant on Education
- (1) Senior Consultant I
- (1) Senior Consultant II
- (3) Quality Assessor

SECTION 2. These Consultants shall perform the following duties:

- 2.1 Consultant on Education
 - Provide coaching competencies aligned with the Basic Education K to 12 Curriculum

- Orient the Senior Workforce on how to improve the academic performance of the struggling learners in Math and Science
- Discuss with the Senior Workforce the priority coaching competencies to be reinforced to the struggling learners
- Suggest and provide time tested strategies in dealing with struggling learners
- Set standards on the coaching process
- Facilitate regular consultation period for debriefing process

2.2 Senior Consultant I

- Coach the participating struggling learners to cope with the academic demands in any of the core learning areas (Math and Science)
- Provide developmentally appropriate assessment materials to determine the coaching outcomes.

2.3 Senior Consultant II

- Adapt with the coaching needs of the struggling learners
- Facilitate enjoyable coaching sessions filled with engaging activities sensitive to the learning styles of the participating struggling learners

2.4 Quality Assessor

- Observe the coaching session and provide feedback for continuous improvement of future sessions
- Prepare assessment materials that will determine academic achievement of the participating struggling learners (pre test, post test, delayed post test design)
- Analyze the regular assessment results, attendance of participating struggling learners and senior workforce
- Diagnose emerging needs during the conduct of coaching sessions.

SECTION 3. The budget for the salaries and other benefits of the appointees to the aforementioned positions shall be taken from the approved 2017 Executive Budget of the City Government of Pasig.

SECTION 4. This Ordinance shall take effect upon its approval.
