**AN ORDINANCE REPEALING ORDINANCE NO. 10, SERIES OF 2013.**

**WHEREAS**, there is a need to repeal Ordinance No. 10, series of 2013, entitled: "An Ordinance amending Section 1, Paragraphs A and B, Chapter IV of Ordinance No. 56, series of 1993 entitled, "an Ordinance prescribing the Rules and Regulations in occupying and using Market Stalls and providing penalties for violation thereof", in order to address the increase in opportunities of investors doing business in the City of Pasig;

**WHEREAS**, Section 1, paragraph a & b, Chapter IV of Ordinance No. 56, series of 1993, read as follows:

**CHAPTER IV – PROHIBITION**

Section 1. **SELLING AND PEDDLING** – No person, partnership, association or corporation shall be engaged in any of the following activities:

- a) For selling, peddling, offering, or exposing for sale any goods, wares or merchandises on the passageways or aisles, vacant spaces, sidewalks and roadway in the public market and an area within the 200 meter radius.
- b) For selling, peddling or offering or exposing for sale outside the public market and within the radius of 200 meters, such goods, wares or merchandises regularly sold or which could be purchased inside the public market.

**BE IT ORDAINED**, by the City Council of Pasig, duly assembled that:

**SECTION 1.** Ordinance No. 10, series of 2013, entitled, "An ordinance amending Section 1, Paragraphs A & B, Chapter IV of Ordinance No. 56, series of 1993 entitled, "an Ordinance prescribing the Rules and Regulations in occupying and using Market Stalls and providing penalties for violation thereof", is hereby **REPEALED**.

**SECTION 2. Separability Clause** – If any provision of this Ordinance is declared unconstitutional or invalid, the provisions not affected thereby shall continue to be in full force and effect.

**SECTION 3. Repealing Clause** – All Ordinances or issuances of the City or parts thereof that are inconsistent with any of the provision of this Ordinance are hereby repealed or modified accordingly.
