AN ORDINANCE PROVIDING INCENTIVES TO THE DULY DEPUTIZED ENFORCERS OF THE CITY GOVERNMENT FROM THE OFFICE OF PUBLIC SECURITY (OPS), BATAS NG CIUDAD ENFORCEMENT OFFICE (BCEO) AND CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) FOR THE IMPLEMENTATION OF ALL ORDINANCES OF PASIG CITY AND FOR OTHER PURPOSES.

**WHEREAS**, in recognition of the active participation and contribution of the Office of Public Security (OPS), Batas ng Ciudad Enforcement Office (BCEO) and City Environment and Natural Resources Office (CENRO), the City Government will provide incentives to them as a sign of recognition to their performance and discharge of functions and duties;

**WHEREAS**, the Office of Public Security (OPS), the Batas ng Ciudad Enforcement Office (BCEO) and the City Environment and Natural Resources Office (CENRO) will served as a multiplying force of the City Government that will be able to give quality and faster service to people of Pasig;

**NOW, THEREFORE**, be it **ORDAINED** by the **SANGGUNIANG PANLUNGSOD**, in session duly assembled that:

**SECTION 1. TITLE** – This Ordinance shall be known as “Incentives to the duly deputized enforcers of the Office of Public Security (OPS), Batas ng Ciudad Enforcement Office (BCEO) and City Environment and Natural Resources Office (CENRO)”.

**SECTION 2. INCENTIVES** - For all the collected penalties attributed to the issuance of Unified Ordinance Violation Receipt (UOVRs), a Fifteen Percent (15%) incentive shall be paid as follows:

- a) Ten Percent (10%) of the collected fines shall be for the duly deputized enforcers of the OPS, BCEO and CENRO, who are authorized to issue an Ordinance Violation Receipt (OVR) of Pasig City based on actual number of apprehensions.
- b) Three Percent (3%) of the collected fines shall be for the administrative expenses of the (OPS), (BCEO) and (CENRO). The fund shall be disbursed only for the operational expenses of the said offices, including maintenance of facilities, excluding salaries and allowances of personnel. Any unused balance at the end of the fiscal year shall be reverted to the General Fund.

- c) Two percent (2%) of the total collections shall be divided equally among equally among the officials and Administrative Staff herein below enumerated including the Chief OPS, Chief BCEO and Chief CENRO or any person designated as Head of the Office.
- d) Any balance of the Fifteen Percent (15%) at the end of the year shall revert to the General Fund.
- e) The grant of incentives as herein provided shall not exceed fifty percent (50%) of the annual salary of the grantee.
- f) All the enforcers and personnel are to be designated by the City Mayor or his authorized representative prior to the entitlement to the foregoing incentives.

**SECTION 3. EFFECTIVITY** - This Ordinance shall take effect fifteen (15) days after its publication in any local newspaper of general circulation and/or posting in the bulletin boards in Pasig City Hall.
