AN ORDINANCE AMENDING CITY ORDINANCE NO. 04, SERIES OF 2017 ENTITLED "AN ORDINANCE PROHIBITING HOME BIRTHS IN PASIG CITY, PROHIBITING TRADITIONAL BIRTH ATTENDANTS TO DELIVER NEWBORNS AND REQUIRING ALL PROFESSIONAL HEALTH PRACTITIONERS TO DELIVER NEWBORNS ONLY IN HEALTH FACILITIES AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 7 of Ordinance 04, Series of 2017 states that:

SECTION 7. Any person who shall violate any provision of this ordinance shall be meted a penalty of:

1st Offense – P1,000.00

2nd Offense – P3,000.00

3rd Offense – P5,000.00 and succeeding offenses

WHEREAS, in order for the said Ordinance to be more effective, a stiffer penalty is needed.

NOW THEREFORE, BE IT ORDAINED by the City Council of Pasig, in session duly assembled that:

SECTION 1. Section 7 of Ordinance 04, Series of 2017 is hereby amended to be read as follows:

SECTION 7. Any person who shall violate any provision of this ordinance shall be meted a penalty of:

1st Offense – P5,000.00 and a warning

2nd Offense – P5,000.00 and Fifteen (15 days) community service

3rd Offense and thereafter – P5,000 and One (1) year imprisonment

Pending the action filed against the violator, the Pasig City Health Department shall report all cases involving a Professional Health Practitioner (PHP) to the Professional Regulation Commission (PRC) for appropriate administrative sanctions. Similarly, pending a same sanction against the Traditional Birth Attendant or Hilot (TBA), all cases involving a TBA/PHP shall be reported to the City Prosecutor's Office for illegal practice of medicine under existing laws. For both purposes the Pasig City Health Department is tasked to formulate a mechanism of reporting these cases to PRC and to the City Prosecutor's Office.

SECTION 3. EFFECTIVITY - This Ordinance shall take effect fifteen (15) days after its publication in any local newspaper of general circulation and/or posting in the bulletin boards in Pasig City Hall.
