AN ORDINANCE AMENDING CERTAIN PROVISIONS IN CITY ORDINANCE NO. 33 SERIES OF 2017 CREATING VARIOUS PERMANENT POSITIONS FOR THE PASIG CITY GENERAL HOSPITAL, ABOLISHING CERTAIN POSITIONS AND REPLACING SAID POSITIONS TO CONFORM TO RECOMMENDATIONS FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM).

WHEREAS, Department of Budget and Management (DBM) and Department of Health (DOH) issued Joint Circular No. 2013-1 on September 23, 2013 providing Revised Standards on Organizational Structure and Staffing Pattern of Government Hospitals;

WHEREAS, the said Joint Circular proposed the revision of the standards on the organization and staffing of government hospitals to make it compliant with the minimum DOH licensing requirements, Philhealth accreditation and new hospital licensing category;

WHEREAS, as prescribed in the said Joint Circular, the highest levels of Midwife and Admin Assistant positions for a level 3 hospital with 300-bed capacity such as the Pasig City General Hospital (PCGH) shall be Midwife II and Admin Assistant III;

WHEREAS, the Department of Budget and Management interposes no objection to the creation of Nurse III and Nurse IV in Ordinance No. 33, Series of 2017, however there are adjustment/revisions prescribed by the DBM for Midwife positions to conform with DBM-DOH Joint Resolution No. 2013-1;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG IN SESSION DULY ASSEMBLED THAT:

Section 1, 2, 3 and 4 of Ordinance no 33, Series of 2017 is hereby amended to be read as follows:

Section 1. CREATION – There is hereby created the position of thirteen (13) Midwife I, Fifteen (15) Midwife II, Eight (8) Nurse III and One (1) Nurse IV under the plantilla of Nursing Service Office of the Pasig City General Hospital in accordance with existing Civil Service laws, rules and regulations.

Section 2. QUALIFICATIONS - No person shall be appointed Midwife I, Midwife II Nurse III and Nurse IV unless he/she is a citizen of the Philippines, a resident of the city, of good moral character, has completed Midwifery and Nursing Courses, a holder of professional civil service eligibility.

Section 3. APPOINTMENT, SALARY GRADE AND COMPENSATION – Midwife I, Midwife II Nurse III and Nurse IV under the plantilla of Nursing Service Office of the Pasig City General Hospital shall be appointed by the City Mayor in accordance with existing Civil Service laws, rules and regulations. He/she shall receive a salary and other allowances and emoluments prescribed by law or ordinance.

Section 4. APPROPRIATION - There is hereby appropriated the sum of **Fourteen Million Seven Hundred Forty Five Thousand One Hundred Forty Eight Pesos and 70/100 (PHP14,745,148.70)** to cover the payment of salaries, allowances and other mandatory personal expenses of Midwife I, Midwife II, Nurse III and Nurse IV under the plantilla of Nursing Service Office of the Pasig City General Hospital created under Section 1 hereof chargeable against the available funds of the city or out of the salary savings from vacant positions as certified by the City Treasurer computed as follows:



Section 6. Effectivity - This Ordinance shall take effect upon its approval.


