**AN ORDINANCE AMENDING CERTAIN PORTIONS OF THE UNIVERSITY CODE OF THE PAMANTASAN NG LUNGSOD NG PASIG (PLP).**

**WHEREAS**, the promotion and delivery of quality education is among the priority development programs of the City Government of Pasig;

**WHEREAS**, in the line with the said program, the Sangguniang Panlungsod ng Pasig enacted Ordinance No. 11 series of 1999 creating the Pamantasan ng Lungsod ng Pasig as a higher educational institution to meet the increasing demand for education advancement accessible to Pasigueños;

**WHEREAS**, in the course of inspection for quality assurance towards institutional recognition of the Pamantasan ng Lungsod ng Pasig by the Commission on Higher Education (CHED), several amendments were endorsed to meet the standards;

**WHEREAS**, the City Council agrees with the proposed amendments by the CHED and hereby resolves for passage of the appropriate amendments to the University Code as follows;

**NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD IS SESSION DULY ASSEMBLED:**

**Section 1.** The adoption on the amendments to the University Code of Pamantasan ng Lungsod ng Pasig in order to comply with the CHED requirements for institutional recognition;

**Section 2.** Composition. The Board of Regents shall be composed of:

- a. The Chairperson, the City Mayor or his authorized representative
- b. The Vice-Chairperson, who shall be appointed by the City Mayor
- c. The Chairperson of the Committee on Education of the City Council, Member
- d. The University President, Member
- e. A representative from the business sector, Member
- f. The President of the PLP Faculty Association, Member
- g. The President of the PLP Supreme Student Council, Member
- h. The President of the Alumni Association, Member
- i. (3) Three prominent Citizens of Pasig who have distinguished themselves in any of the professions or fields of specialization of

PLP who may be appointed by the City Mayor, upon recommendation of the Sangguniang Panlungsod, Members;

- j. A Board Secretary who has no voting power and whose main function is to produce the official minutes of the meetings and is custodian of the BOR documents;

"The members from c) until h) are required by the Commission on Higher Education; of the three (3) prominent citizens of Pasig, the City Mayor shall designate (1) one to serve for (1) one year; (1) one to serve for (2) two years and (1) one to serve for (3) three years. Thereafter, persons appointed to succeed each member shall have been qualified and appointed. In each of the vacancy, the position shall be filled by appointment of the City Mayor and such appointee shall hold office for the remainder of the term."

**Section 3.** The Chairman of the Board of Regents in his capacity as City Mayor, shall appoint the President, who shall have a term of four (4) years and shall be eligible for re-appointment.

**Section 4. SEPARABILITY CLAUSE.** – In the event that any of the provisions of this ordinance or parts thereof are declared unconstitutional or invalid, the other parts not so affected shall remain in full force and effect.

**Section 5. REPEALING CLAUSE.** – All ordinances, rules and regulations as well as executive orders, or parts thereof, in conflict or contrary to the provisions of this ordinance are hereby repealed, amended, or modified accordingly.

**Section 6. EFFECTIVITY.** – This ordinance shall take effect immediately upon its approval.
