WHEREAS, in the pursuit of cultural preservation for maintaining the Pasigueño identity and the conservation of traditional and historical sites, and in honor of the great Filipino Revolutionary Andres Bonifacio, the City of Pasig has developed the old Pariancillo Park formerly known as Rio De Pasig Linear Park located at Alcalde Jose, this City naming it to Plaza Bonifacio;

NOW, THEREFORE, be it ORDAINED that:


Section 1. The Pariancillo Park formerly known as Rio De Pasig Linear Park located at corner F. Concepcion Street, Alcalde Jose, Barangay Kapasigan, Pasig City is hereby named as Plaza Bonifacio.




SECTION 4. Effectivity. This Ordinance shall take effect immediately upon approval.
