AN ORDINANCE CREATING THE POSITION OF ADDITIONAL FIVE (5) NUTRITIONIST DIETITIAN II IN THE REGULAR PLANTILLA OF THE PASIG CITY HEALTH OFFICE (CHO), PRESCRIBING QUALIFICATIONS, SALARY GRADE, DEFINING ITS DUTIES AND FUNCTIONS, COMPENSATION AND APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES.

BE IT ORDAINED by the City Council of Pasig in session assembled that:

Section 1. CREATION - There is hereby created the position of additional five (5) Nutritionist Dietitian II, in the regular plantilla of the Pasig City Health Office (CHO) in accordance with existing Civil Service laws, rules and regulations.

Section 2. QUALIFICATIONS - No person shall be appointed Nutritionist Dietitian II unless he/she is a citizen of the Philippines, a resident of the city, of good moral character, has completed Bachelors Degree Major in Nutrition, Dietetics.

Section 3. APPOINTMENT, SALARY GRADE AND COMPENSATION - Nutritionist Dietitian II, under the plantilla of government positions in Pasig City Health Office (CHO) shall be appointed by the City Mayor in accordance with existing Civil Service laws, rules and regulations. He/she shall receive a salary equivalent to Salary Grade 15 and other allowances and emoluments prescribed by law or ordinance.

Section 4. TERM OF OFFICE - The term of office of the Nutritionist Dietitian II under the plantilla of Pasig City Health Office (CHO) shall be permanent in nature.

Section 5. APPROPRIATION - There is hereby appropriated the sum of **One Million Four Hundred Twenty Three Thousand Five Hundred Five Pesos & 70/100 (P1,423,505.70)** to cover the payment of salaries, allowances and other mandatory personal expenses of the Nutritionist Dietitian II under the plantilla of government positions in Pasig City Health Office (CHO) created under Section 1 hereof chargeable against the available funds of the city or out of the salary savings from vacant positions as certified by the City Treasurer computed as follows:





Thereafter, the appropriation of the salary and other allowable fringe benefits shall be included in the annual budget of the City Government.


Section 7. EFFECTIVITY - This Ordinance shall take effect upon its approval.






