AN ORDINANCE AUTHORIZING THE CITY MAYOR TO UPGRADE THE POSITION AND SALARY GRADE OF THE ASSISTANT DEPARTMENT HEAD I TO ASSISTANT DEPARTMENT HEAD II IN THE CITY OF PASIG.

WHEREAS, Section 458 (a) (1) (viii) of the Local Government Code provides that the Sangguniang Panlungsod is empowered to determine the position and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

WHEREAS, by virtue of Republic Act 7829 otherwise known as the Charter of the City of Pasig, converting the Municipality of Pasig into a highly urbanized city, the City Government of Pasig automatically adopts the upgraded titles and salary grade levels for personnel items/positions prescribed of a highly urbanized city;

WHEREAS, the City Government of Pasig recognizes the efficiency and effectiveness of the employees of the city government to adjust and upgrade the position from Assistant Department Head I to Assistant Department Head II, provided that, said implementation shall not exceed the personnel services cost limitation in the current budget and is consistent with and in accordance to the Salary Standardization Law and other pertinent laws.

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG, IN SESSION DULY ASSEMBLED THAT:

Section 1. The City Mayor is hereby authorized to upgrade the position and salary grade of Ms. Ma. Theresa B. Sibal, from Assistant Department Head I (Salary Grade 23) to Assistant Department Head II (Salary Grade 24) in the City of Pasig.

Section 2. The budgetary requirement to implement this Ordinance shall be chargeable against the Compensation Adjustment Fund in the 2018 budget of the City Government.

Section 3. The Ordinance shall take effect immediately upon its approval.
