AN ORDINANCE ADOPTING MMDA RESOLUTION NO 17-20, SERIES OF 2017 IN RELATION TO SYNCHRONIZING THE FINES AND PENALTIES FOR SELECTED TRAFFIC VIOLATIONS COMMITTED IN THE CIRCUMFERENTIAL AND RADIAL ROADS IN METRO MANILA.

WHEREAS, members of the Metro Manila Council have agreed to synchronize the fines and penalties for selected traffic offenses commonly vomited by motorists in Metro Manila;

WHEREAS, Local Government Units in Metro Manila were urged to adopt MMDA Resolution synchronizing the fines and penalties for selected traffic offenses in their respective areas of jurisdiction;

WHEREAS, the City Government of Pasig in coordination with the MMDA aims to strengthen its efforts in managing the traffic situation in major thoroughfares particularly the circumferential and radial roads in Metro Manila.

NOW THEREFORE BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG IN SESSION DULY ASSEMBLED THAT:

SECTION 1. SCOPE – This Ordinance shall cover fines and penalties for selected traffic violations committed in the Circumferential and Radial Roads in the City of Pasig.

SECTION 2. Responsible Agency – Officers and Supervisors of the Traffic and Parking Management Office (TPMO) shall be deputized in the enforcement of this ordinance.

SECTION 3. FINES AND PENALTIES – Any person apprehended for violating this Ordinance shall be penalized as follows:

SECTION 4. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared unconstitutional or invalid, the provision not affected thereby shall continue to be in full force and effect.

SECTION 5. REPEALING CLAUSE. All ordinances, rules and regulations or part thereof, in conflict with or inconsistent with any provision of the Ordinance are hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY – This Ordinance shall take effect fifteen (15) days after publication in any local newspaper of general circulation within the City of Pasig and posting of public notices in Pasig City Bulletin Board.

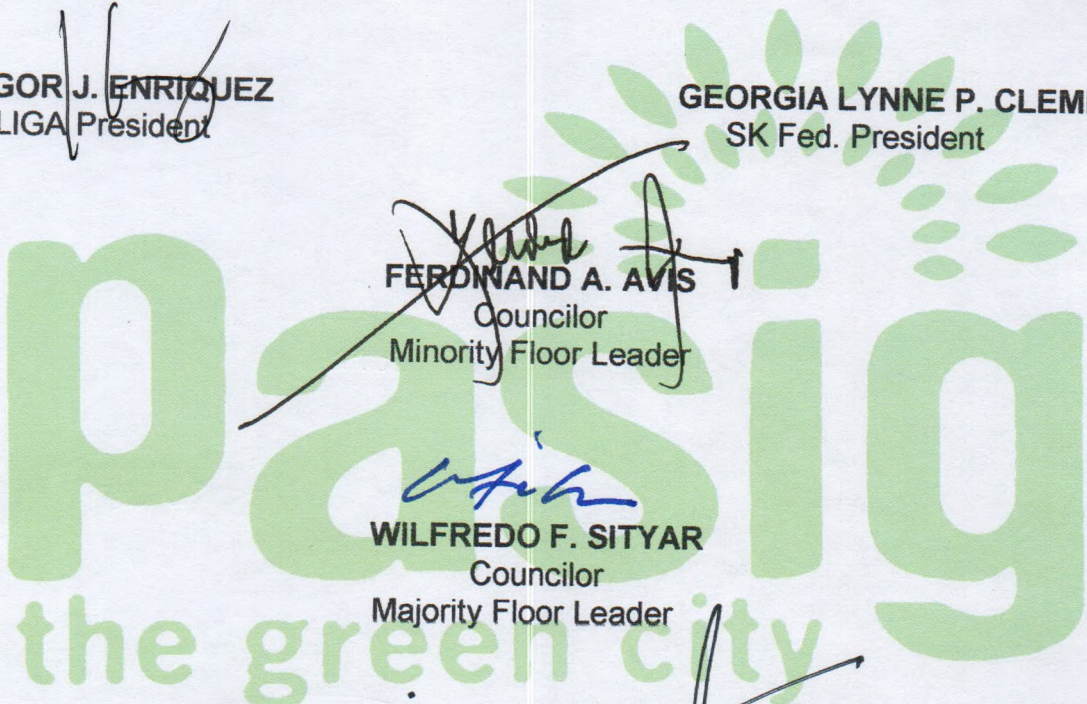
